New Coroner's Office: On August 28, 2013, we had our open house for the new Coroner's Office. This project went very quickly from start to finish and will provide the residents of San Luis Obispo County a state of the art facility. In addition, the facility provides a location for the Deputy Coroners to meet with families during a very difficult time in their lives.

This facility was built without general fund money and is an example of how a little creativity doesn't need to cost the tax payers. Of course this project would not have been possible without the support of the Sheriff's Advisory Foundation (SAF). As you recall, I approached the SAF Board over a year ago with the idea for this project and without hesitancy the board agreed to get behind the project.

There is a plaque in the lobby of the facility that recognizes this support. Thank you to the Sheriff's Advisory Foundation for your continued support of the men and woman of the Sheriff's Office.

Adopted a New Baby: The Sheriff's Office adopted a new baby! That baby is in the form of another four legged friend. This is our fifth K-9 and is assigned to the custody division.

already been successful. Dutch was paid for with asset forfeiture funds, just like the other K-9's.

The property/evidence room is expected to be complete around the first of the year and the women's jail is expected to break ground after the first of the year.

This position is vital in our efforts to provide and educate the public. Rob was a tough act to follow but not only is Tony up to the task but I am convinced that Rob is very pleased with our selection.

We have been extremely busy, which I blame on Tony's arrival, and the members of the Sheriff's Office have stepped up and answered the call. We have a couple homicides and several other significant cases. We recently announced the arrest in the Cambria homicide and this was an excellent example of hard work and team work.

I continue to receive many thank you letters from the public for the excellent work performed by members of the Sheriff's Office.

Thanks to the Members of the Sheriff's Advisory Foundation: In closing, I would again like to thank the members of the Sheriff's Advisory Foundation for their continued dedication to the Sheriff's Office and the community.


Sheriff's Office New State of The Art Coroner Facility Sheriff's Advisory Foundation Donates \$29,000

Autopsies & Investigation of All Reportable Deaths: The Sheriff-Coroner or his designee is responsible for investigation of all reportable deaths that occur within the county of San Luis Obispo. In order to determine the cause and manner of death, many cases require an autopsy or medical examination. Autopsies are typically conducted once per week by a certified Forensic Pathologist along with one or more of our three full-time Detective Coroners. Last year, there were 1,441 reported deaths in the County of San Luis Obispo, which has steadily increased since 2002. Of those reported deaths, the Coroner's Office conducted 281 autopsies/medical examinations last year, or approximately 5 per week.

Historically, a Dedicated Coroner's Office Facility Did Not Exist: Throughout the history of the Sheriff's Office there has never been a dedicated Coroner's Office facility to conduct such investigations and procedures. The Sheriff's Office utilized local mortuary facilities to conduct autopsies and examinations. The Coroner Unit has used the preparation room of a local mortuary as the designated autopsy facility for the last ten years. As industry standards increased, the facility no longer was able to meet the safety, efficiency and evidentiary needs of the Sheriff's Office. Therefore, in order to protect employees and provide the best service to the citizens of San Luis Obispo County, the Sheriff's Office needed its own Coroner Facility.

Sheriff Parkinson Recognized the Need for Such a Facility: When Sheriff Parkinson was elected, he recognized the importance and need for such a facility for the San Luis Obispo County Sheriff's Office. Through his hard work and partnerships with community leaders, he was able to secure a location to serve the needs of the Sheriff's Office and the citizens of San Luis Obispo County. His vision for the future made this project possible.

Project Began in November of 2011: The Coroner Facility project began in November of 2011. With a lot of hard work and leadership from the Sheriff, the project was completed in just ten months. In addition to the expedient completion of the project, it was completed with no additional costs to the Sheriff's Office budget. The funding for equipment necessary for operation came entirely from the generous support of the Sheriff's Advisory Foundation and asset forfeiture money. The Sheriff was able to open the new Coroner Facility for less than \$100,000.00 in one



time costs, which is truly remarkable.

Payments to Private Mortuary: Last year the Sheriff's Office paid \$62,190 to a private mortuary for the use of their facility to conduct autopsies, with an additional cost of \$8,400 paid for cleanup services. Those expenditures are part of the Sheriff's Office annual operating budget. These fees will now be used to cover the lease of the new Coroner Facility and its related services. In other words, it will be cost neutral and will result in no net increases to the Sheriff's Office budget and will have no additional impact on the San Luis Obispo County General Fund.

New Coroner Facility: The new Coroner Facility is a state of the art facility which will accommodate the needs of San Luis Obispo County for many years to come. Safety, security and efficiency are now the cornerstones of the Coroner's Office. The autopsy suite, forensic room, evidence room, conference/viewing room, refrigeration and associated office space are pivotal in allowing investigators to provide the best service possible to the citizens of San Luis Obispo County. Whether the investigation is an unexpected natural death or a homicide investigation, the new Coroner's Office is equipped with all the recourses necessary to ensure that any investigation is conducted with the utmost professionalism and integrity.







SAN LUIS OBISPO COUNTY 19th CENTURY OUTLAW - LAWMAN HISTORY

"Why can't a Locomotive sit down? ? Because it has a tender behind."

Article provided by Jack Jones

Taken from the San Luis Obispo Tribune, September 2, 1876.

With that bit of dated humor, we learn that the Sheriff's Office of San Luis Obispo was having a relatively easy month of September. It appeared that a man who said his name was Joseph Mc Laughlin was brought in from Paso Robles and turned over to the Sheriff.

He had made a poor attempt to commit suicide by slashing his throat. He related that he had departed San Francisco in August by foot, walking down the coast attempting to find work ending up about two miles north of Paso Robles. He grew very disheartened and depressed from exposure and hardship which compelled him to slash his throat in a desperate act.

He bled profusely, but did not die because he did not cut

the jugular vein. He was found by a Mexican who took him to a house across the river, from thence he was transported in a cart to the hot springs where a doctor sewed up his wound and bathed him which somewhat revived him. After dinner he was removed and taken to the county hospital.

Mc Laughlin gave his age as 32 years and said he had friends in Philadelphia and Indiana. He desired to return to San Francisco and then to the east and his friends. The Sheriff and hospital staff arranged for him to leave the county as soon as he was able.

Even 136 years ago, the Sheriff's Office lived up to its "Protect and Serve" reputation. □□□

Sheriff's Advisory Foundation Conducted the 1st Annual Bike Auction



**WILLOW ROAD PROJECT PHASE II AND HIGHWAY 101 WILLOW ROAD INTERCHANGE
NOW COMPLETE**

SAN LUIS OBISPO COUNTY – A ribbon cutting ceremony for the U.S. Highway 101 Willow Road Interchange Project will be held on Friday, October 26, 2012, at 3 pm in Nipomo. The public is invited to attend the event. Access for parking will be Thompson Avenue and parking will be near the new Nipomo Creek Bridge. The event will include the ribbon cutting ceremony with local and state representatives and a soap box car derby race.

After decades of planning, environmental review, design, and construction, the Willow Road completion will provide a direct link between State Route 1 and Highway 101 and a new interchange at Highway 101. The completion of this project will also provide area residents with the ability to travel from the west mesa to Thompson Avenue providing additional access to the Nipomo High School and Olde Towne Nipomo.

The \$20 million construction project was completed by Granite Construction of Santa Maria. This project was funded by South County road improvement fees, the County of San Luis Obispo, the San Luis Obispo Council of Governments, Prop 1B State and Local partnership Program funds, and the California Transportation Commission. The completion of the project is five months ahead of schedule due to Granite's construction efforts and has been delivered approximately \$1 million under budget.

The new freeway access will be open for public use beginning October 27, 2012, after the ribbon cutting ceremony.

As part of the project mitigation, the Department of Public Works is developing a 22.8 acre oak woodland habitat on County property adjacent to the Dana Adobe. The woodland enhancement provides mitigation for the disturbance caused by the interchange construction. A contract to plant 4,000 acorns will be set later this year.



 SEPTEMBER 30, 2012 AND SEPTEMBER 30, 2011**



REVENUES-SEPTEMBER 30, 2012 AND SEPTEMBER 30, 2011**








