GENERAL MANAGER'S REPORT

ITEM

Standing report to your Honorable Board -- Period covered by this report is April 5, 2014 through April 18, 2014.

DISTRICT BUSINESS

Administrative

- Drought continues throughout the State and region. The winter of 2013-2104 is on track to be one of the driest on record.
- The Nipomo Mesa Management Area groundwater basin levels are at their lowest recorded level in the forty-year record. The County of San Luis Obispo is scheduled to read area water well levels this month. Once this data is available the Nipomo Mesa Management Area Technical Group will calculate the 2014 Key Wells Index. It is widely expected that the Index will indicate Severe Water Shortage conditions for the area groundwater.
- The District's Supplemental Water Project, Phase 1 is under construction and on schedule for completion in July 2015. Phase 2 of the project will be pursued prior to the completion of Phase 1 if funding is available.
- The District continues to encourage all customers to conserve water. Annual average customer water use has declined steadily since the District implemented an inclining tiered water rate structure in 2011. However, customer demand last fall and this winter was higher than typical due to the lack of rainfall.
- Implementation of drought rates (premiums on top of existing rates) and/or water use restrictions may be necessary this summer if winter rain fall levels remain low.
- San Luis Obispo County maintains two rain gauges in the area. One is located at the District's Southland Wastewater Plant (Nipomo South) and one at the District's Tefft Street water storage site (Nipomo East). In the past two weeks, neither gauge registered any precipitation. The seasonal rain total for Nipomo South is 4.5-inches. Average for this gauge is 16-inches per year. The seasonal total for Nipomo East is 5.5-inches. Average seasonal rainfall total for Nipomo East is 18-inches.
- On April 7, the District issue a Will Serve for sewer service to a newly replaced mobile home in Galaxy Park.







Water Shortage Response Plan & Proposed Drought Rates

This Plan Will Help Manage Water Supplies During Drought by Reducing Water Use to Match Water Availability

The District recently approved a Water Shortage Response Plan with the following features:

1. Five Escalating Drought Stages

This Plan is based on five escalating stages of drought. These stages are based on the courtmandated water use limits that are designed to protect the groundwater basin.

Targeted Water Use Reduction by Voluntary Conservation

customers. In higher stages, there are targeted reductions in overall water use designed to protect long-term groundwater supplies. At stages 3, 4 and 5 the targeted reductions are 30%, 50% and As the drought stages escalate, the plan calls for increasing levels of voluntary conservation by 60% respectively. The later stages represent extreme drought that has not occurred to-date.

3. Processing Permits for New Water Would Decrease—Then Stop

In stage 4 new water connections would only be made to existing commitments. In Stage 5 no new water service connections would be made

This would call for a targeted 30% cutback in water use.
June	Likely 30% Conservation Cutbacks. Presumed 30% cutback in water supplies due to Stage 3 drought. District will seek to achieve cutback through voluntary conservation by customers.
May - October	Coordinate with Neighbors for Shared Conservation and Supplemental Water Responsibilities. Work with neighboring water suppliers to finalize agreements for them to purchase their share of supplemental water and institute similar conservation programs and rates. Work with the County to implement water resource management policies to protect the basin and fund ourchase of new water studies for any new development.

The District has succeeded in obtaining supplemental water supplies and is constructing essential, but costly facilities to bring that water to our community. Construction is already underway and new water supplies will begin to be available starting next year. This long –term investment will benefit the community for decades to come.

<u>The District is developing a Water Shortage Response Plan and associated drought rates</u> to motivate customers to reduce water use. These rates are still being developed.



Reading Water Meters - As Easy as 1-2-3

2. Read the digits >>>


The dial will have a row of numbers similar to a car odometer, a sweep hand, and a 'tell-tale' triangle. Meter faces vary. A typical meter is shown below.

Furthest right on the row of numbers are white numbers on a black background. These record 1's and 10's of cubic feet. Each time the sweep hand goes full circle, 1 cubic foot of water passes through the meter and the farthest right number increases by one.

Note: I cubic foot = 7.4 δ gallons of water.

Numbers change to black on a white background as you move left on the dial. The first row of black numbers on white background (from the right) measures 100's of cubic feet. Example read:





Record ALL the numbers again; this is Read #2 (515313).



Subtract Read #1 from Read #2 (515313-514828); this equals the cubic feet used (485). Multiply this number by 7.48 to get gallons used (3,627).

Once finished reading the meter, close the meter dial cover. Carefully replace the meter lid and Close meter dial cover and replace the meter lid >>>

Meter Reads and Billing:

example above, the customer would be billed for 5 'units' of water: (485 cubic feet+100=4.85 or rounded to 5 units) Water meters register in cubic feet, but the District bills in 100 cubic feet increments, or 'units.' Based on the 748 gallons = 100 cubic feet = 1 unit of water for billing purposes

In a two-month billing cycle, the average District customer uses 36 units of water which equates to approximately 27,000 gallons of water (36 units x 748 gallons). The District sells 1 unit of water (748 gallons) for about \$3 which works out to less than 1/2 of 1 penny per gallon.

Board Actions Address Water Shortage and Drought

At its regularly scheduled meeting on April 9, 2014, the Nipomo Community Services District Board of Directors took three steps to address the long-term groundwater decline which has been made worse by the current drought.

First, after hearing public comments, the Board unanimously approved a resolution adopting a Water Shortage Response Plan. This Plan is based on five escalating stages of drought. In the higher stages, there are targeted reductions in water use designed to protect the long-term groundwater supplies. As the stages escalate, the plan calls for increasing levels of voluntary conservation by customers. It also defines how the District will suspend processing requests for new water service in advanced stages of drought.

Second, to motivate customers to conserve water, the District is proposing special drought rates designed to signal customers to reduce water use should advance stages of drought be experienced. The Board reviewed these rates, which are proposed to be based on the same five stages in the Drought Response Plan. In stages three through five, the drought rates are proposed to motivate people to conserve increasing amounts of water, and also make up for the financial loss from reduced water sales.

General Manager, Michal LeBrun pointed out that, "The escalating rates approach lowers impacts on customers who are already conserving. Those who use less, pay less."

Third, the District has succeeded in obtaining supplemental water supplies and is constructing essential, but costly facilities to bring that water to our community. Delivery of supplemental water is planned for summer 2015. At the April 9 meeting, the Board of Directors reviewed a Supplemental Water Charge that is proposed to be levied when the new supply becomes available.

Taken together, the drought response plan, proposed drought rates, and the new supplemental water supply and proposed charges form a comprehensive response to the current water shortage situation both in the near term and the long run.

Details of the proposed drought rates and supplemental rates are still being developed. The Board is scheduled to receive a presentation outlining the proposed rates at its next Regular Board Meeting on April 23rd at 9 AM in the District Board Room, 148 South Wilson, Nipomo. Additionally, Public Workshops to discuss the rates are scheduled to be held the week of May 5th.

Nipomo CSD grappling with water shortage

The Nipomo Community Services District plans on continuing to take aggressive steps, including a possible charge to existing rates, to deal with a rapidly depleting groundwater basin.

Nipomo CSD relies solely on groundwater to meet the rural community's demand for the wet stuff, and to meet those needs the water purveyor had to pump 60 percent more in January than it did during the previous year.

At its meeting late last month, NCSD directors reviewed a draft Water Shortage Response Plan that addresses the depletion of the groundwater basin caused by decades of overpumping across the region as well as the state's record-setting drought, said NCSD General Manager Michael LeBrun.

"We've been saying, and so has everyone else, that overpumping (of the groundwater basin) has been occurring for the last 10 or 20 years," LeBrun said. "Now we have a drought and the situation is being exacerbated."

This year's pumping increase represents an average of 6.3 acre-feet per day of water being pulled from the basin by the NCSD, something the already stressed aquifer can't sustain for any length of time.

An acre-foot is about 326,000 gallons, or the amount generally considered needed to supply four to 10 people a year with water.

The NCSD shares the massive aquifer with other three water purveyors — Golden State Water, Woodlands Mutual Water and Rural Water companies. The basin also serves users — commercial, residential and agricultural — in southern San Luis Obispo and northern Santa Barbara counties. This year's levels in the aquifer have been at their lowest measurement since 1975.

"We have to significantly reduce the amount of groundwater we are pumping," LeBrun said.

When the district directors meet Wednesday, April 9, the board is expected to adopt the draft water response plan that provides a range of alternative actions — possibly not issuing any new will-serve letters until more water is on tap — the NCSD can take in response to water emergencies.

The NCSD has contracted with Santa Maria to purchase a share of the city's state water and is in the process of constructing a multimillion-dollar pipeline to bring the water north. The new water supply is expected to be available starting next year.

During the April 9 meeting, district directors also are expected to begin discussing adding an across-the-board charge to all four tiers of water rates in

Nipomo in the hopes that customers will reduce their water use, LeBrun said.

"We have to do all we can to conserve water," he said.

The new charges — a premium that would be added to existing rates — are proposed to be based on a set of five escalating drought stages.

At each higher stage, the premium would increase to encourage people to conserve the amount of water they use and also make up for the financial loss by the district from reduced water sales due to higher costs, LeBrun said.

The NCSD serves about 12,000 people and 40 businesses and has been operating under a "Stage 2," meaning a potentially severe water shortage exists, water condition for the past several years.

If the proposed water rate premium is approved, LeBrun said it would likely become effective toward the end of June or beginning of July.

Gathering spot is in the works in Nipomo

Plans for a small park named for one of the founding members of the Nipomo Community Services District are moving ahead, with just enough space for a small veterans' memorial, a marker honoring Dorothea Lange's "Migrant Mother" photo and a gazebo.

Kathy Kubiak, longtime president of the Olde Towne Nipomo Association, is now seeking donations to develop the approximately 0.68-acre Jim O. Miller Memorial Park at West Tefft and Carrillo streets.

Kubiak anticipates it will cost at least \$200,000 to finish designing and building the "town-center park," described as a little gathering spot for the community where concerts could be performed at the gazebo. The park will be landscaped, she said, with a mixture of grasses and drought-tolerant plants.

"Once it's designed, we will also have to find donations of materials, including piping for irrigating plants," Kubiak said. "In two to three years, we'll see this park to fruition."

She said the association is working with Paul Martin Lester, a professor at Cal State Fullerton, to seek grant funding to create a marker recognizing the famous photo Lange took of Florence Owens Thompson and her children in February or March of 1936 in Nipomo.

Fundraising for the veterans' memorial will be handled by the Veterans of Foreign Wars-Nipomo, she said. The plans for the park predate the Olde Towne Nipomo Association, which was formed about 20 years ago to improve the historic downtown area of Nipomo between Thompson Avenue and the railroad tracks that paralleled Carrillo Street and Nipomo Creek.

The Nipomo Community Services District pursued the park's creation about five years ago, but plans stalled after residents voted against an assessment district to pay for maintenance. After that, the Olde Towne Nipomo Association took the lead. The location of the park has changed slightly from the northeast corner of Tefft and Carrillo streets to the south side of West Tefft Street after sampling found the soil was contaminated by a leaking oil pipeline and heavy metals.

The contamination was likely caused by deterioration of an old railroad warehouse that was demolished in the 1950s, according to county officials.

The community services district on Wednesday will consider waiving service charges and fees for the park. Several fundraising barbecues are planned to raise money for the park April 13, May 18, June 22, July 20, Aug. 17, Sept. 21 and Oct. 19.

All will be held from 11 a.m. to 3 p.m. in the Miner's parking lot at 553 W. Tefft St. For information and a sketch of the park, go to www.facebook.com/OldeTowneNipomo.

Nipomo water rates could rise to pay for new pipeline and drought effects

Residents who live within the Nipomo Community Services District boundaries could face higher water rates if a severe drought condition is declared.

Customers in the Nipomo district — which includes about 12,000 people and 40 businesses — may also see their bills rise in order to pay for water coming to the community through a pipeline from Santa Maria.

The Nipomo district board on Wednesday received information on the proposed rate increases but will formally consider them May 14. After that, residents would have a chance to protest the increases, with a public hearing tentatively scheduled for July 9.

In addition, the board approved a water shortage response plan that outlines specific actions the district could take if the groundwater basin falls to extremely low levels or there's evidence of seawater intrusion.

A few board members and local residents worried about how the increases would affect community members living on a fixed income. Another underlying concern remains whether other water users on the Mesa, including other large water purveyors, are going to take similar steps to prompt their customers to conserve.

"Nipomo does not have a water shortage problem; the entire mesa has a water shortage problem," resident Dan Hall wrote in comments submitted to the board. "As with the North County, this is a county problem, and solutions for conserving water need to be shared by all parties, including the users of rural wells."

Nipomo residents have one source of water: an enormous underground aquifer that serves parts of southern San Luis Obispo and northern Santa Barbara counties. Besides Nipomo district residents, other users on the Nipomo Mesa include water purveyors Golden State Water Co., Rural Water Co. and Woodlands Mutual Water Co.; the Phillips 66 oil refinery; and about 1,000 private wells.

Last year, wells in the area dropped to their lowest level on record. An update on the status of the basin is expected in May.

"I hope the intent and goal here is collaboration with neighboring supplies so they work in concert with us," said resident Ed Eby, a former district board member. "If we raise our rates, they raise theirs."

Nipomo district customers are in the midst of annual rollout of rate increases approved in 2011, with water rates scheduled to increase 9.5 percent this November and in November 2015.

Whatever action the board takes on additional rate hikes would be on top of the existing increases, officials said. The drought-related rate increases could be put into effect only after a severe water shortage condition is declared; they were described as one tool the board could use to reduce its groundwater pumping.

The board chose to reduce water use through rate increases, not mandatory conservation. The district would urge customers to conserve, but would not impose mandatory measures, which can be costly to

enforce, district general manager Michael LeBrun said.

The average customer currently uses nearly 27,000 gallons of water every two months and pays \$108.99. Under the proposed rates, that customer would pay \$163.23 if a more advanced drought condition were declared (called Stage 3).

The district has been operating under a Stage 2 condition since spring 2008, meaning that a potentially severe water shortage exists. The board also discussed charging a fixed fee of \$39.79 to pay for the cost of supplemental water that it's agreed to purchase from Santa Maria.


