Standing report to your Honorable Board -- Period covered by this report is September 6, 2013 through September 20, 2013.

DISTRICT BUSINESS

<u>Administrative</u>

- Recruitment for Wastewater Supervisor, Utility Operator and Customer Service vacancies continues: Conducted a written test for the 70+ customer service applicants. Interviewed Supervisor and Operator candidates.
- The District received a memorandum and report from Citigroup Global Markets Inc. (the District's underwriter for two recent financings) reviewing the timelyness and associated savings of the District's recent borrowing (attached).
- Administrative staff received an all-day presentation by Tyler Technologies on the company's billing and accounting software.
- District received notice from South County Sanitary Service (Garbage service franchisee) of a 2014 Interim Year Rate Increase (attached). Staff will review the request and bring to your Board for consideration at a future meeting.
- District received recognition from Special District Risk Management (District's liability insurer) for no paid worker's compensation claims in 2012-2013 (attached).
- District renewed its contract with Science Discovery to provide classroom education programs covering water conservation topics to local grade schools. The District cofunds the program with Golden State Water Company. The annual costs of the program is under \$2,000.
- Most recent data from Nipomo area County rain gauges recorded no rain during the past two weeks. County rain gauges are reset on July 1 each year. The Nipomo South gauge (Sensor 730) measured total rainfall for the year of 7 inches, 44% of the 16-inch annual average. The Nipomo North gauge (Sensor 730) measured 5.9 inches for the past year, 33% of the 18 inch annual average. Twitchell Reservoir reports 0.0% capacity (at gauge minimum); Lopez Lake stands at 63.5% capacity (31,353 Acre-feet).

Hope you all are well.

With the increase in interest rates over the course of this year, we would like to provide you with a brief update on the pricing results the District received in its 2013 transactions. With growing expectation that the Fed will begin tapering its quantitative easing program, municipal bond rates have increased along with the increase in Treasury rates and mortgage rates.

We analyzed the impact of these increases in interest rates as they relate to the District's two transactions this year. Specifically we examined if the District had priced the transactions now in September (which we recognize may be hypothetical given the wet season construction issues on the new money side) rather than the pricings in late May and mid-June, the transactions results would have been as follows:

REFUNDING - The refunding would not have produced debt service savings had the District waited to price the bonds. While the actual transaction produced debt service savings of approximately \$109,000, current rates would result in debt service that would have been approximately \$364,000 higher than the actual pricing results and as such the refunding debt service would have exceeded the refunded debt service and the District would not have executed the transaction.

NEW MONEY - The increase in interest rates from the June 19th new money pricing to September would have carried total debt service cost that would be \$2.7 million higher. This would be an additional expense of \$85,000 annually and from a present value perspective it would have cost approximately \$1.4 million more to finance the new money projects.

We hope this helps provide some perspective on the timing of the District's financings. You were well served to get your transactions priced and executed prior to the increases in interest rates which occurred over the course of the summer.

If you have any questions on this analysis or if we can provide any additional information, please let us know.




The refunding transaction was priced in late May. If the District had waited to execute the refunding until later in the year, the refunding would not have produced debt service savings.



Re: 2014 Interim year rate increase request

We are requesting a 2.05% across the board increase for all rates. An increase of \$2.25 per ton for the disposal of garbage at Cold Canyon Landfill, accounts for 0.96%. The cost of operations is 1.09% of the increase.

The manual actually calls for an increase of 2.78%. That is limited by the cumulative cola section of our franchise agreement. I have included a copy of that calculation.

Hopefully, we can get back on track with a January 1st effective date. Call me with questions.

This letter is to formally acknowledge the dedicated efforts of the Nipomo Community Services District's Governing Body, management and staff towards proactive loss prevention and workplace safety. Your agency's efforts have resulted in no "paid" workers' compensation claims for program year 2012-13. A "paid" claim for the purposes of this recognition represents the first payment on an open claim during the prior program year. This is a great accomplishment!

It is through the efforts of members such as Nipomo Community Services District that SDRMA has been able to continue providing affordable workers' compensation coverage to over 399 public agencies throughout California. In fact, 242 members or 61% in the workers' compensation program had no "paid" claims in program year 2012-13.

In addition to this annual recognition, members with no "paid" claims during 2012-13 earn 2 credit incentive points (CIPs) thereby reducing their annual contribution amount. Also, members without claims receive a lower "experience modification factor" (EMOD) which also reduces their annual contribution amount.

As SDRMA is dedicated to serving its members and preventing claims, we would appreciate your agency taking a moment and sharing with us what made your District successful in preventing work related injuries. Our goal is to incorporate your successful ideas and suggestions into our loss prevention programs to benefit all members of SDRMA. 





NIPOMO CSD BOARD OF DIRECTORS DENY AGRICULTURAL REQUEST FOR WATER

On Wednesday, September 11th, the District's Board held their regular meeting at 9AM and, with a 4-0 vote (Blair absent), denied Ramco Enterprises' request for water service via a metered hydrant.

On September 4th, Ramco Enterprises requested water service via a hydrant meter for periodic 'weather related' emergency use. Ramco operates an agricultural business outside the District's service area and primarily produces strawberries. They stated "our irrigation well capacity has lowered and we are in need of more water for irrigation primarily during weather-related emergencies."

The Board recognized Ramco's hardship, but denied the request due to concerns about water resources in the Nipomo area and upheld a District ordinance which states "District water will be provided only for single-family domestic purposes. The water shall not be used for irrigation or commercial husbandry or crop growing purposes."

A similar request for water services was presented by a Nipomo resident at the August 14th meeting and denied due to concerns about local water resources.

NCSD rejects 2nd outside water request

Wells going dry in northeast area of Mesa

A second request in as many months for water service outside Nipomo Community Services District boundaries was rejected by the board of directors Wednesday.

Directors voted 4-0, with Bob Blair absent, to deny a request to provide emergency water to an agricultural operation at the end of East Dana Street from a nearby fire hydrant.

At its Aug. 14 meeting, directors denied a Hetrick Road homeowner's request to receive direct water service from NCSD pipelines.

The requests are the result of falling groundwater levels that have reduced production in some private wells and caused others to go dry in the northeastern portion of the Nipomo Mesa.

James Rietkerk of Ramco Enterprises requested the emergency water service that was denied Wednesday.

"We have organic strawberries and our irrigation well capacity has lowered and we are in need of more water for irrigation, primarily during weather-related emergencies," Rietkerk said in his application.

The request denied last month came from Hetrick Road resident Jim Davis, who has been trucking in water at a cost of 10 cents per gallon, according to NCSD documents.

"It's been almost four years since our well went dry and we are still in desperate need of a water supply," Davis said in his application. "Connection to the NCSD water (system) is our only viable long-term option."

Both are symptoms of a groundwater supply that's threatened by more water being pumped out than is being replaced by rainfall during the current drought that stretches back to 1990, said Michael LeBrun, NCSD general manager.

"Wells over in this area have dropped precipitously," LeBrun said, noting levels in the Nipomo Mesa groundwater subbasin this spring were 30-percent lower than last year.

A recent report from Nipomo Mesa Management Area Technical Group, which monitors the health of the subbasin, showed groundwater at the lowest level since recordkeeping began in 1975, he said.

"We have anecdotal reports of wells going dry in the North Thompson (Avenue) and Summit Station areas," LeBrun said after the meeting.

"People call the office and say, 'My well's gone dry. How can I hook into the district's water?"

Sorry, you can't," he said.

Mike Winn, a former NCSD director, noted during public comment that a well at a Nipomo citrus operation fell 70 feet last year.

"One of the things that gets lost in this is that we're really in a statewide drought," Winn said. "There is no prognosis for even average rain anytime soon."

Recently, district employees caught someone from the local area stealing NCSD water by hooking a tank truck into a hydrant in Maria Vista Estates.

"It's a further indication folks are getting desperate," LeBrun said.

Although policy allows NCSD to provide water outside its boundaries under certain circumstances, it prohibits supplying that water for agricultural operations.

"I really feel for them," Director Larry Vierheilig said. "Unfortunately, the way (the policy) is written, our hands are pretty much tied on this. And I do like strawberries."

LeBrun said the Davis request would have been much more complicated to fulfill, requiring approval of the Local Agency Formation Commission.

The LAFCO application would cost \$10,000, with no assurance it would be approved; the district's capacity charge and in-lieu fee to join the Summit Station district would be about \$30,000; and Davis would face additional costs to run a water line to his property.

Wells are going dry in Nipomo, too

The Community Services District has denied requests for emergency water at its past two meetings

Like the Paso Robles groundwater basin, the Nipomo underground aquifer has seen precipitous declines in recent years, and some farms and residences are beginning to feel the pinch.

At its past two meetings — one Wednesday and the other Aug. 14 — the Nipomo Community Services District denied requests for emergency water from a farmer and homeowner outside the district whose wells are going dry.

District employees also recently caught a resident illegally filling a truck with water from a district hydrant. The incident was reported to the San Luis Obispo County Sheriff's Office, said Michael LeBrun, district general manager.

"It's a further indication that folks are getting desperate," he said.

The groundwater aquifer beneath Nipomo has been classified as being in decline since 2007. The Paso Robles and Los Osos basins are also in decline, and Cambria also has chronic water shortages.

Drought conditions this year significantly worsened the Nipomo groundwater crisis, LeBrun said. Aquifer levels were 30 percent lower this spring than last spring and are the lowest they have been since recordkeeping began in 1975. At Wednesday's meeting, the board denied a request for emergency water from Ramco Enterprises, a company that grows strawberries on 80 acres adjacent to the district. The directors were sympathetic to the plight of the farm, but district policy only allows emergency sales of water outside the district to residences.

"You really hate to see anyone in a hardship situation, but we have no excess capacity," Director Dan Gaddis said.

At its Aug. 14 meeting, the board denied a request for water from a residence outside the district. District policy allows for emergency water sales to residences outside district boundaries, but only on a temporary basis. The homeowners were denied because they wanted a long-term hookup to the district's water system, LeBrun said.

Mike Winn, a former CSD director, urged the board to be very careful about emergency water requests. The district's water crisis is so severe that rationing will likely be necessary if drought conditions persist, meaning golf courses and school lawns could start turning brown.

Formed in 1965, the Nipomo CSD serves 4,000 water customers and 2,500 sewer customers. The district is constructing a supplemental water pipeline to Santa Maria that is expected to be complete late in 2014.

Last year, voters turned down \$26 million in property taxes to pay for the pipeline, but the district is going ahead with the project in phases.

Nipomo Denies Requests for Emergency Water

NIPOMO, Calif. -- More water woes in San Luis Obispo County, this time in the city of Nipomo. The Nipomo Community Services District has seen its water reserves decline so much it had to deny several requests for emergency water.

At the past two meetings, a farmer and homeowner from outside the district were denied access to the emergency water because there just isn't enough to go around.

The district general manager says a homeowner was denied the request because he wanted a LONG TERM hookup to the water system...but emergency sales to outside residents are only allowed on a TEMPORARY basis.

The farmer was denied because the district's policy only allows emergency sales to residences NOT FOR agricultural purposes.

"People are getting desperate-that's in relation to the fact that we've had a number of requests now for outside water use for emergency where folks' wells have gone dry or the production of those wells is diminished. This past week, we caught someone hooked up to our system with a water truck stealing water from our system."

The district sells water to outside users at a rate of \$5 per 750 gallons.

The district has seen its aquifer levels 30 percent lower this spring than last and at the lowest level since the 1970s.

To alleviate this problem, the district is working on a water pipeline to Santa Maria that should be complete in 2014.

The district met with its finance and audit committee Thursday to undertake a rate study to determine how much the cost of the water rate will increase once the pipeline is complete.

Shining a light on transparency

Interview with five District Transparency Certificate of Excellence recipients

Over the last couple of years, the abuses that have come to light in various public agencies have brought increased scrutiny as it relates to transparency. Many agencies have already made commendable efforts to be transparent to the public through use of their websites and public outreach. Even more agencies continue to work and improve on making themselves readily transparent to the media and those whom they serve. This year, the Special District Leadership Foundation (SDLF) developed a certificate to acknowledge and showcase special districts that have demonstrated an outstanding commitment to transparency: the District Transparency Certificate of Excellence.

California Special District interviewed five districts – of all sizes, budgets and service types – that have received the certificate to find out why they feel it is worth earning and how it has helped them in their public outreach efforts.

The district has felt for many years that we have been very transparent through our website, blog and meetings. We believe this was an excellent way to show proof of that.

What has your district gained by achieving this certificate? Were there any unexpected benefits? Primarily, the certificate helps us to continue to build credibility with our

customers. It is one thing to say, "We're the water experts, so trust us," but another to have established that we are an open, trustworthy organization so we don't have to ask for that trust. It demonstrates that we have nothing to hide and that we stand behind the work that we do.

Additionally, even though we felt good about our transparency efforts before applying for the certificate, the program gave us the chance to comprehensively review all of the initiatives we've taken to maintain openness and to renew our support of these efforts. After several years of posting our budget document to our website, for example, continuing to do so can become a routine rather than a meaningful step to build confidence in our customers. Achievement of the certificate has helped to restore perspective in some of these steps.



Our board and the public recognize that we strive to be open and be forthcoming with our financial records. The bar has been raised by gaining the Transparency Certificate of Excellence. We have received positive comments from the public about our efforts to be transparent.



We improved our level of transparency with our customers, thereby broadening and improving our customers' understanding of district functions,

The unexpected benefit was that we realized our need to update, clarify and expand some of our resolutions - and by utilizing the special districts recognition it was very easy to do.

Earning the certificate demonstrates a commitment to engaging the public and creating greater awareness of your district's activities. How has gaining this certificate affected your public outreach efforts?

Going through the application process for the Transparency Certificate helped us to recognize where additional steps could

be taken on our website to improve customer access to information. For example, we had not previously featured links to any information about how to be considered as a candidate for the board of directors. 3 finalists confirmed for Teixeira's supervisor seat

Candidates were interviewed for the supervisory district covering South County

It has been nearly three months since San Luis Obispo County Supervisor Paul Teixeira died of a heart attack, and his seat on the board remains unfilled by Gov. Jerry Brown.

The Tribune has learned of three candidates who were given face-to-face interviews with the governor's appointments staff in Sacramento, which means they are finalists for the job. The Board of Supervisors' 4th District includes much of the South County including Nipomo and Arroyo Grande.

Mike Winn of Nipomo, Mike Byrd of Arroyo Grande and Arroyo Grande City Councilwoman Caren Ray have confirmed that they are finalists. They described a lengthy process of applying for the job, which included filling out an online application, being interviewed by phone and ultimately traveling for an inperson interview in Sacramento.

"It's pretty amazing the depth of their staff's knowledge on the issues here," said Byrd, a South County real estate agent. "They don't take this lightly."

Officials with the Brown administration say no official details about the appointment process are available and there is no deadline for the governor to make a decision. Officials would not release a list of those who have applied.

"The administration does not release information about prospective appointees in order to maintain the privacy and confidentiality of the applicants," said Jim Evans, a spokesman for the governor.

The three candidates and others who follow the process say Brown is nearing a decision. County Supervisor Adam Hill said he recently called the governor's office to check on the process.

"I was told that they had completed their work and were simply looking to get a spot on the governor's schedule," he said. "And after that, it's all up to the governor — who and when."

Whoever is appointed will have to begin campaigning for election to a full term if he or she wants to keep the seat. The term expires at the end of 2014, and candidates will first face off in June in the primary election.

The process began with those interested in the job filling out an online application. Winn said it took him five hours to complete the application, which covered income taxes, employment history, education and community and military service.

A telephone interview with applicants was the second part of the process. The governor's appointment staff asked about information in the application as well as standard job interview questions such as why they wanted the position and why they thought they would do a good job.

The applicants who were not invited for face-to-face interviews received a letter thanking them for their willingness to serve.

The in-person interviews covered some of the same information as the phone interviews, as well as questions about important issues facing San Luis Obispo County such as the Paso Robles groundwater basin crisis.

"My interview was about three weeks ago, and I haven't heard anything since then," Winn said.

Now, it's just a matter of waiting.

"As is the case with all our appointments, our focus is selecting the best possible candidates," Evans said. "That ultimately dictates our timing."

The California Legislature recently finished its session, and the governor has a lot of bills to read and consider, so it is understandable that it would take him time to make a decision, Winn said.

"I don't think there is any reluctance to make the appointment," he said. "But he can only get to it when he gets to it."

Others said they are glad that Brown is being deliberative about his decision.

"While we need an appointment as quickly as possible to get the people of District 4 represented again, the fact that it is taking so long should reassure citizens that the governor is taking this seriously and doing as much homework as necessary to get this decision right for the county," Ray said.

A 1999 state Court of Appeal ruling upheld the governor's power to withhold the names of applicants, said Jim Ewert, general counsel for the California Newspaper Publishers Association.

In that case, the California First Amendment Coalition sought names of applicants for a vacancy on the Plumas County Board of Supervisors after being denied the information by Gov. Pete Wilson. The court ruled that the governor has the right under the "deliberative process privilege" not to release the names, which could create a chilling effect by discouraging potential applicants, Ewert said.
