GENERAL MANAGER'S REPORT

ITEM

Standing report to your Honorable Board -- Period covered by this report is December 6, 2014 through January 9, 2015.

DISTRICT BUSINESS

Administrative

- Nipomo area groundwater is in a potentially severe water shortage condition as defined by the court appointed group that monitors basin health. The District is in Stage II (2) shortage conditions as defined by its Water Shortage Response and Management Plan.
- The District uses an active education and outreach program and escalating block water pricing to encourage water conservation. District water rates are set such that water in the highest block cost 300% more than in the lowest. By design, these escalating prices reward conservation and penalize water waste. The District approach to conservation is both frugal and effective.
- Our customers ended the year with strong water conservation efforts in both November and December. Early season rainfall resulted in reduced irrigation demand and attributed to the 30 and 40% reduction in District water pumping during November and December 2014, as compared to 2013. On the year, the District pumped 16% less water in 2014 than in 2013. Or 725 million gallons of groundwater pumped in 2014 versus 862 million gallons in 2013. See the attached table and graph summarizing District groundwater production.
- Construction of the District's supplemental water pipeline is progressing on schedule, with over \$600,000 of construction cost expenditure in December. Initial water deliveries expected by July 2015.
- On January 5, Mr. Russ Newman joined the District in the position of Chief Plant Operator/Wastewater Supervisor. On January 12, Mr. Kenneth Brown will join District in the position of Customer Service/Maintenance Worker.
- All three Intent to Serve letters approved by your Board on December 10, 2014 have been issued.
- On December 19, the District noticed the owner of Village at Nipomo of non-compliance with District water service standards resulting from recent subdivision of the property.
- On December 22, the District issue a leak repair notice to La Placita Plaza, APN 092157026.

Customer Service Contact

During the month of December, five hundred and twenty-one (521) customers came to the District office. 95% came to pay their bill. Staff received an additional two hundred thirty-two (232) service inquires via phone during the month.

Fire Hydrant Metered Use

The District provides limited water sales via metered fire hydrant for construction and other in-District requests and local county projects. Project specific hydrant meters are set upon request and a hydrant located adjacent to the District office is outfitted with a meter for common use.

During the month of December, three project specific hydrants were in service. Only two of these hydrants metered use; 29 units (~22,000 gallons) metered by the Speiss Construction hydrant meter and 2 units (~1,500 gallons) Halsell Builders on Mads Circle. Speiss Construction is constructing the District Supplemental Water facilities, Halsell is constructing new homes. Additionally, 7 units of water (~5,200 gallons) were utilized at the common hydrant meter for County projects, including street sweeping.

Connection Report

One new water connection was added to the District system in December making for a total of twelve new water connection added during 2014.





District Customers to Receive One-Time Discount on Trash Bills

District customers will see a one-time 50% reduction in their bi-monthly solid waste bills (commercial accounts will see the discount on two one-month bills).

The District holds a Franchise Agreement with South County Sanitation for providing solid waste collection services within the District. A small portion of the fees collected by the Sanitation Company from customers within NCSD is paid to the District as a franchise fee.

The District uses franchise fees to fund community wide cleanup efforts including sponsorship of Creek Day, funding the Chamber of Commerce's Keep Nipomo Clean program, and providing trash receptacles in Olde Towne. However, District solid waste reserves have grown over the years and the Board of Directors directed staff to return the excess funds to those who contributed

The discount is scheduled to be applied on bills for the months of January and February 2015. For example, if a customer's two-month solid waste bill is normally \$60, they will see a \$30 discount on their bill.

In 2015, the District will celebrate 50 years of service to the community of Nipomo.

The District was formed in January 1965 by a group of community leaders who recognized that Nipomo needed to address critical water quality and supply problems.

In February 1966 property owners within the new District's service boundary passed a property tax measure to secure \$650,000 for building the District's first water system. Construction began in June 1966 and water began to flow in November 1966. In the early part of the 1980's, the District embarked on a sewage collection and disposal system project. The sewer project was constructed in 1984-85 and became operational in 1986.



Our freshly decorated truck is just one way we are stressing that water conservation measures — and real money savings — start with your outdoor landscape. Choosing less-thirsty, drought-tolerant plants can help you save significant amounts of water and cash.

Changes to your landscape and shutting down your irrigation system this winter can help you double your water savings.

Winter is the perfect time to plant along the Central Coast. Mild temperatures make the digging easy and help new plants to become established. Rainfall helps to minimize the water needs of new plantings.

If planted in the early winter, most droughttolerant and native plants will need supplemental water for just one summer. The following year's winter rains will help the plants become firmly

established and infrequent watering, at most, will be all that is needed from then on.

Without spending any money, many homeowners could significantly reduce the amount of water used in their landscape. Overwatering landscapes is surprisingly common, and the well-drained soils in our area often hide the symptoms.

By spending some time getting familiar with your landscape and irrigation system, you could reduce watering and save money while still maintaining the appearance of your current landscaping.

I was recently talking with a water-conscientious customer, and she asked; "How many times a week should I be watering my established drought-tolerant native plants?" My answer was: "Zero for the next five months, and next summer water them — give them a good soak — once a month, maybe twice if weather is very warm and dry."

More than ever, now is the time to consider reducing the water demands of your landscaping, either by changes in your watering patterns or landscape type or both.

There is a great deal of information on the district's website and other local and online sources regarding water-use efficiency and converting to low-water-use landscapes.

If you need some help getting started, call the district office, and our staff will help point you in a water-conserving direction.





Nipomo CSD's pumping continues to decrease and its customers are once again to be thanked for the collective conservation effort. The District has seen a reduction in pumping every month since July.

November pumping data shows a reduction of 27% from last November. The month-to-month amount pumped has also decreased significantly, from 201 acre feet in October to 144 acre feet in November. That is 18 million gallons LESS water from our aquifer.

The District customers continue to do their part and we are very close to achieving the 30% reduction goal our Board of Directors asked for this past July! Customers who are saving water are also seeing smaller water bills making water conservation that much more rewarding.

Now that shorter days, winter rains and cooler temperatures have arrived, customers are encouraged to turn off irrigation systems until spring and see how low they can get their winter water bill. Most landscapes require little to no water in the winter.

NCSD Customers Will Receive 50% Discount on Solid Waste Bill

The Nipomo Community Services District Board of Directors approved a one-time discount to District customers' solid waste bill. District customers will see the one-time 50% reduction in their January/February bi-monthly solid waste bills (two one-month bills for commercial accounts).

The District holds a Franchise Agreement with South County Sanitation for providing solid waste collection services within the District. The Agreement generates a fee paid to the District as a proportion of the fees collected by the Sanitation Company from customers within NCSD.

The District uses franchise fees to fund community wide cleanup efforts including sponsorship of Creek Day, funding the Chamber of Commerce's Keep Nipomo Clean program, and servicing the garbage common cans in Olde Towne. However District solid waste reserves have grown over the years and the Board of Directors directed staff to find a method to return the excess funds to those who contributed to them.

The District's solid waste Committee reviewed a number of options and felt a direct return of the funds to all District customers, both residential and commercial, by subsidizing the garbage bill was the most equitable and efficient way to spend the reserve down.

Director Bob Blair who chairs the Board's Solid Waste Committee stated "This is how government should work, if we collect more money than we need, we return it to the people we collected it from!"



NCSD asking customers to stop irrigating

Now that the days are shorter, the weather is cooler and the South County has received more than 2 inches of rainfall, Nipomo Community Services District is encouraging customers to turn off irrigation systems through spring.

For the majority of NCSD customers, most of the water they use goes to irrigating landscapes, an NCSD spokesman said.

Most landscapes require little to no supplemental watering in the winter because plants go dormant or their metabolism slows down, and even under drought conditions, enough rain will fall to sustain their life.

That means customers can completely turn off irrigation systems without causing any visible impact to shrubs, lawns and other groundcover, the spokesman said.

Customers who greatly reduce water use will also see significant cost savings on their bimonthly water bills.

Currently, the district has a goal of reducing overall water use by 30 percent and approaching that target, with pumping from the groundwater basin ranging from 20 to 27 percent less than last year.

Pumping down significantly in NCSD area

Nipomo Community Services District's pumping from the groundwater basin continued to decrease in November, thanks to the collective conservation effort of its customers, officials said.

November pumping data showed a reduction of 27 percent from November 2013, officials said.

The amount pumped from month to month also decreased significantly, from 201 acre-feet in October to 144 acre-feet in November.

That represented 18 million gallons less water that was drawn from the aquifer.

An acre-foot is about 326,000 gallons, or the amount of water generally considered necessary to supply the annual needs of four to 10 people in an urban environment.

NCSD has experienced a reduction in pumping every month since July, an NCSD spokesman said, and summertime pumping was 20 percent less than that of summer 2013.

"The district customers continue to do their part, and we are very close to achieving the 30-percent reduction goal our board of directors asked for this past July," the spokesman said.

"Customers who are saving water are also seeing smaller water bills, making water conservation that much more rewarding."

NCSD customers to see discount on trash bills

Nipomo Community Services District customers will receive a one-time 50-percent reduction in their next sold waste bills.

The NCSD board of directors approved the one-time discount for the January/February billing period for residential customers. Commercial accounts will receive the discount on their onemonth bills for the two months.

The district holds a franchise agreement with South County Sanitary Services for providing trash collection within NCSD boundaries, a district spokesman said.

Under the agreement, South County Sanitary pays the district a portion of the fees collected from district customers.

NCSD uses the franchise fees to fund communitywide cleanup efforts, including sponsoring Creek Day, funding the Nipomo Chamber of Commerce's Keep Nipomo Clean program and servicing the public trash cans in Olde Towne.

However, the district's solid waste fund reserves have grown over the years, so the board directed the staff to find a method to return the excess funds to customers, the spokesman said.

NCSD's Solid Waste Committee reviewed a number of options and decided the most equitable and efficient way to spend down the reserve was a direct return of funds to all residential and commercial customers.

"This is how government should work," said Director Bob Blair, who chairs the committee. "If we collect more money than we need, we return it to the people we collected it from."

Nelson told the Mojave Desert News the small two-room building is used for Boy Scout meetings. In an adjacent storage area, the Scouts kept a variety of tools, equipment and paperwork in lockers. All of that was turned upside down and scattered.

The Scouts had a meeting in the room Saturday morning but when they returned Sunday morning they were faced with the vandalism.

The intruders spray-painted graffiti, including obscenities, on the walls, floor and water cooler in fluorescent blue, green, red and bright pink paint.

They left empty paint cans behind, the newspaper reported.

There was also a small patch of charred residue on the floor that indicated an attempt to start a fire had not succeeded.

California City Police officers were called, and an investigation is ongoing.

The scoutmaster said the incident shows the importance of having organizations like the Boy Scouts in the community to provide an outlet that discourages malicious behavior.

The Scouts have begun to clean up the mess but said they feel violated by the destruction.

SAN LUIS OBISPO: Cal Poly San Luis Obispo has ratcheted up drug testing of its student-athletes after an alleged armed robbery that involved football players.

According to the San Luis Obispo Tribune, five football players were named in an alleged drug-related robbery at a fraternity house in August.

One player was charged with allegedly brandishing a gun and demanding money or drugs from fraternity members.

Since then, the university has tightened its drug testing policy.

In the past three months, the school has spent more than \$14,000 to conduct 197 tests on its 550 student-athletes, athletic director Don Oberhelman told The Tribune.

In September, 149 tests were performed on student-athletes, including all 105 football players, Oberhelman said, with 12 testing positive for a substance banned by the NCAA.

Cal Poly's on-campus drug and alcohol educator Theresa Fagouri told The Tribune that the national average for marijuana use among 18- to 24-year-olds in higher education is about 15 percent.

After the alleged robbery, Cal Poly signed a contract with The National Center for Drug Free Sport and settled on spending up to \$27,000 this academic year on drug testing.

Athletes who have tested positive once will continue to be tested regularly.

Each test costs the school about \$71, Oberhelman said.

That's more money than the school was paying for its previous level of standard testing. But this new system tests for more substances than marijuana.

To educate its athletes on drug awareness, Cal Poly is working closely with educators and law enforcement to talk to students on and off campus.

Both the football coach and athletic director said this year's incident has prompted them to rethink recruiting strategies, The Tribune said.

Coaches are looking for players who want to be there, not just because their mom and dad are graduates of the school.

They want athletes that understand what playing for Cal Poly requires in order to be a part of the tradition.

Some San Luis Obispo County residents are voicing disagreement with a recent decision by county supervisors.

On Tuesday, the supervisors approved a one-time healthcare offset payment of about \$1,000 to the county's 2,400 employees.

The payments, according to The Tribune, are meant to help county staff defray the rising cost of healthcare insurance.

The payments total \$2.4 million.

Dan Buckshi, a county administrator, said an employee who chooses family coverage could spend as much as \$708 in out-of-pocket expenses each month.

Nearly 10 people attending a meeting on the subject spoke against the payments, saying they were unfair because people who don't work for the county are also having to deal with the rising costs of health insurance.

According to The Tribune, the county is able to make the one-time payments because it ended the most recent fiscal year with a \$30 million surplus.

Buckshi said the county will also begin to restore county department budgets and reserves that were drawn down when the recession hit.

High-end, expensive wine was allegedly stolen by an ex-employee at a downtown San Luis Obispo restaurant.

On Monday, the Granada Hotel & Bistro called SLO police to report the theft of four bottles of expensive wine from a cellar, the priciest coming in at about \$1,400.

After reviewing surveillance footage, the hotel staff identified the man who forced his way into the bistro from the adjoining hotel as 32-year-old Matthew Nocas.

Nocas was a former employee who was in charge of ordering wine for the restaurant, the officer said.

A search warrant was issued and patrol officer Caleb Kemp went to the home of Nocas, where he found four bottles, unopened, chilling in a mini fridge, The Tribune reported.

The bottles ranged from a 2008 bottle of Domaine Romanee-Conti, Romanee St. Vivant pinot noir worth \$1,400 to a 2008 Muga Rioja priced at \$118.

In total, Nocas had about \$2,300 worth of wine in his garage, police said.

Nocas was arrested and booked into San Luis Obispo County Jail. On Wednesday, according to The Tribune, he was no longer in county jail and had not yet been scheduled for an arraignment in court.

Restaurant owners declined to speak to the Tribune about the incident.

Nipomo residents will have to get used to seeing brown lawns until the spring.

In an effort to reduce water use, Nipomo Community Services District officials urged customers to stop watering their lawns and plants until next year.

With the little rainfall the city received -- Nipomo received about an inch of rain in Tuesday's storm -- the district thought it would be best to encourage its customers to stop irrigation, The Tribune reported.

During the winter most landscapes don't need much water so home owners can save money by turning off their outdoor irrigation system.

The Nipomo Mesa has one source of water -- an underground aquifer that services communities in southern San Luis Obispo and northern Santa Barbara counties.

TAFT: A lottery ticket worth \$700,000 was sold in Taft for the second time at the same convenience store.

The winning ticket correctly matched the numbers 13-24-30-42 and 48, missing only the Powerball number of 27.



January through December

Did someone say water?

This last year, many of the topics of discussion for LAFCO centered on the issue of water. We have covered a number of water-related matters and provided sound information that has helped LAFCO and the public work through the issues in an informed manner. From the Heights annexation to the City of Arroyo Grande which results in a net reduction in water demand for the City of Arroyo Grande, to the potential formation of a Water District in the North County, the Commission has provided a forum to discuss these issues in a respectful, in-depth, and solution-oriented manner.

We have also looked at the broader issues of the drought and how it might impact jurisdictions' abilities to provide water service in the future. The past year has been one of rising to the challenge of addressing the water issues in a manner that is balanced and objective. As you will find below, the Commission has provided careful guidance not only on the topic of water, but also in the consideration of a number of other proposals and Sphere of Influence and Municipal Services Review Updates. Working together with Cities, the County, Districts and Land Owners we have accomplished LAFCO's mission of providing for orderly development and efficient services, as well as, the preservation of open space and agricultural land. The list of the highlights is found below and a meeting-by-meeting summary of the year follows.

When you place all of these activities end-to-end, the year has been very busy and productive. It has been a pleasure to serve the Commission this past year. We thank you for that opportunity and look forward to what promises to be an exciting and interesting 2015.

2014 HIGHLIGHTS

During 2014, San Luis Obispo LAFCO evaluated and approved a number of proposals, provided information and assistance to the public, and considered a number of status reports. The Commission also adopted Sphere of Influence Updates and Municipal Service Reviews, and participated in CALAFCO legislative and annual conference program activities.

<u>Proposals</u>

 Approval of Busick/Vista Heights Annexation. The Commission conditionally approved the 48-acre annexation to the City of Arroyo Grande based on a water conservation plan that will reduce overall water consumption by the City. LAFCO and the City required that a open space easement be recorded on the property to preserve 15 acres of oak trees and open space on the property. 31% of the site.

- Approval of Annexation No. 24 to the Templeton Community Services
 District Creekside. A 24 acre District owned parcel just east of the town of
 Templeton was added to the District. The property has two District operated wells
 located on the property. A Permit was approved by the County to allow the
 construction of a Fire Training facility. Prime Agricultural land must be set aside
 on 1 acre preserved per 1 acre developed basis.
- Approval of Annexation No. 89 to the City of Paso Robles Ernst 1-R-13.
 This 1.4 acres parcel was immediately west of the City limits and south of Pacific Avenue on which half of a single family home was situated. The other half of the home was situated on 1.1 acres within the City limits. The house was split by the City/County limit line.
- Approval of Ground Squirrel Hollow Community Services District -Activation of Solid Waste Power. Approximately nine thousand dollars (\$9,000) in annual franchise fees would be transferred from the County to the GSHCSD. A protest process was noticed and conducted with only one protest being received. The District's Solid Waste power has been activated.
- Dissolution of County Service Area 17- California Valley 4-R-14. The County initiated the proposal to dissolve CSA 17. The District had not provided services in many years, fully re-paid all debt financing, and was no longer needed for the provision of services.

Sphere of Influence Updates

- Approval of Coastal CSD SOI/MSR Update. The Coastal CSD's Sphere of Influence and Municipal Services Review was updated in August 2014. Water and wastewater service capabilities were studied to an increased level for the Coastal CSDs of Cambria, Los Osos, and Avila Beach. The Cambria Healthcare District was also reviewed. The Sphere of Influence for each jurisdiction remained unchanged.
- Approval of Special Districts SOI/MSR Update. The Special District's Sphere
 of Influence and Municipal Services Review was updated in November 2014. The
 Sphere of Influence was maintained for Garden Farms Community Water District,
 Port San Luis Harbor District, Santa Margarita Fire Protection District, Coastal
 San Luis Obispo Resource Conservation District, and the Upper Salinas/Las
 Tablas Resource Conservation District.

Other Key Activities

- Water Status Reports: These reports were submitted in February, March and April and May of 2014. The topics covered included the Drought and local response, Governing Structures for Groundwater Basins, the Formation Process for a California Water District, AB 2453, Pavly/Dickinson/Groundwater Bills, and the Formation Process for the Paso Robles Basin Water District under AB 2453.
- Paso Robles Water Basin District Formation. Staff has also worked with other groups and the public offering information regarding formation process of a district, LAFCO's role in the formation, as well as other pertinent information.
- 2014 LAFCO Directory of Local Agencies. The Directory provides basic information about the public jurisdictions (Cities and Special Districts) delivering services to the residents in San Luis Obispo County. The Directory includes an up-to-date map for each jurisdiction that shows the existing service boundary and the Sphere of Influence, as well as water and sewer rates. It also contains a history of the annexations for each jurisdiction.
- Special District Representative. LAFCO Staff is in the process of completing the election process for the Special District position held by Marshall Ochylski. This process involves noticing the 35 Special Districts about the position and requesting nominations and then sending out a ballot for voting to the Special Districts if two or more candidates are nominated. The election is being conducted via electronic mail and ends on January 31, 2014.
- The LAFCO Website has been updated and is being maintained by the LAFCO Clerk to be information rich and user friendly. Donna Bloyd, the LAFCO Clerk has been working diligently to maintain and improve the website. We continue to work on it to make sure it is meeting the needs of the public, applicants, and other LAFCO stakeholders. Please visit the LAFCO website at www.slolafco.com. Any suggestions for improvement are welcome.
- CALAFCO is the statewide organization of LAFCOs and is dedicated to meeting
 the continuing educational needs of staff and tracking legislative activity in
 Sacramento. The SLOLAFCO EO serves as one of the Deputy Executive
 Officers to the Board of Directors of CALAFCO and coordinated the CALFCO
 University classes over this last year and participated in the planning for the
 Annual Conference and the Staff Workshops.

SUMMARY OF MEETINGS IN 2014

January

January started with updating LAFCO's Policies and Procedures. Each LAFCO is required, by the Cortese-Knox-Hertzberg Act of 2000, to establish written policies and procedures that encourage and provide for well-ordered and efficient urban development patterns as well as the preservation of open space and agricultural land. Minor changes and clarifications were made.

A small annexation (Ernst) was approved to the City of Paso Robles to clean up a house split by the City Limit line. The Commission approved the second quarter budget status report. A Legislative update was also reviewed. The 2014 work plan was submitted as well. Discussion of the Los Robles Del Mar lawsuit was on the agenda for closed session.

February

February's agenda included the approval of the Policies and Procedures Update that was discussed in January. Also considered was the activation of the Solid Waste power for the Ground Squirrel Hollow Community Services District. Continued Legislative update was reviewed. A number of Bills were discussed in the Staff Report. The Commission was briefed regarding the State and Local water circumstances. The Los Robles Del Mar lawsuit was on the agenda for closed session.

March

In March the Commission approved the Ground Squirrel Hollow Community Services District-Activation of Solid Waste Power. The Commission considered and approved the 2014 Local Directory Update. The Commission considered a Water Status Report regarding governance options, Bulletin 118 water agency types, and other groundwater information. The Commission completed the Executive Officer's annual performance review. The Los Robles Del Mar lawsuit was was on the agenda for closed session.

April

• The Commission approved the Budget for the upcoming fiscal year 2014-15. The Commission received an update regarding Coastal Community Services Districts Sphere of Influence Update and Municipal Service Review. The Commission held a water study session on governance options. The Third Quarter FY 2013/14 Budget Status Report was received by the Commission. The Commission took action to support CALAFCO bills regarding Omnibus and JPA's requesting the Executive Officer to write a letter of support.

May

In May a continuance was requested for the Coastal Community Services
Districts Sphere of Influence Update and Municipal Service Review. Additional
discussion was heard regarding the water status report. The Formation Process
for a California Water District Report and AB 2453 Update was reviewed.

June

• In June the Commission heard the Coastal Community Services Districts Sphere of Influence Update and Municipal Service Review and continued the item until August for final action. A Legislative update was reviewed. A status report was reviewed of recently submitted proposals and activities including the Ernst Annexation to the City of Paso Robles, Busick SOI amendment to the City of Arroyo Grande, and the Activation of the Solid Waste Power for Ground Squirrel Hollow CSD.

August

• In August the Commission considered and filed the Final Financial Report for past Fiscal Year 2013/14. Approved the 48-acre annexation to the City of Arroyo Grande Annexation No. 31 (The Heights) to the City and the South San Luis Obispo County Sanitation District, Detachment from County Service Area 21. The Commission also approved the Coastal Community Services Districts Sphere of Influence Update and Municipal Service Review.

September

• In September the Commission approved the 24-acre annexation to the Templeton Community Services District. A status report regarding the Special Districts Sphere of Influence Update and Municipal Service Review was given. Follow-up on groundwater legislation regarding AB2453-Achadjian for the formation of the Paso Robles Basin Water District, AB 1739-Dickinson and SB 1168-Pavley, sustainable management of groundwater resources in California.

October

 The 2014 CALAFCO Conference was held in Ontario at the Airport from October 15-17. A voting delegate and alternate delegate were appointed with two Commissioners and two staff in attendance. The Executive Officer served on the conference's program committee and coordinated the groundwater session.

November

 In November the First Quarter FY 2014/15 Budget Status Report was received by the Commission. The Commission took action to dissolve County Service Area No.17. The Sphere of Influence Update and Municipal Services Review for the Special Districts were approved. The Commission also held a study session regarding the Paso Robles Water District Formation Guide.

SAN LUIS OBISPO LAFCO

WORK PLAN – JANUARY 2015

This document is the Work Plan for San Luis Obispo LAFCO in 2015. LAFCO's overarching legislative goals include the following:

- <u>Encourage Orderly Growth and Development.</u> LAFCO considers proposals for the formation of new local governmental agencies including Cities and Special Districts. LAFCO is also responsible for considering annexations and detachments for agencies. LAFCO also determines the Sphere of Influence, which is a plan for the probable physical boundary of a City or Special District.
- <u>Promoting Efficient Provision of Public Services</u>. LAFCO reviews proposals based on a
 variety of factors including: a plan for services submitted by the agency, resource and
 infrastructure capacity, and the need for services.
- <u>Preserve Agricultural Land Resources</u>. LAFCO considers the impact that a proposal may have on existing agricultural lands with focus on prime agricultural lands. San Luis Obispo LAFCO has adopted specific policies regarding the preservation of agricultural resources.
- Discourage Urban Sprawl. Urban sprawl can best be described as irregular and disorganized growth occurring without apparent design or plan. By discouraging sprawl, LAFCO limits the misuse of land resources and promotes a more efficient system of services by local governmental agencies.

Goals in 2015

- 1. Serve the Commission and the public by providing accurate, clear and well-organized information for decision making.
- 2. Serve the Cities, County and Special Districts by providing information about LAFCO's purpose and the processes LAFCO is authorized to complete.
- 3. Process proposals in an efficient manner; consistent with the Cortese-Knox-Hertzberg Act, CEQA and other state laws.
- 4. Implement the Sphere of Influence/Municipal Service Review Update Work Plan, while working on applications and other topics at the same time.
- 5. Provide the Commission with regular status reports regarding upcoming proposals, Sphere of Influence Updates, Legislative Activities, and the Budget.
- 6. Participate in CALAFCO events to improve and enhance the Commission and Staff's expertise.
- 7. Inform the Commission and Public regarding the formation of Paso Robles Basin Water District.

POTENTIAL ANNEXATIONS

Several Cities may have annexation proposals on the horizon. Annexations to Special Districts are more difficult to predict. The Memorandum of Agreements between the Cities and County help set the path for these annexations by providing the provisions for development of an area. Annexation Proposals that may be on the horizon include:

- Farmhouse Lane Annexation to the City of San Luis Obispo
- Robert Hall-Vina Robles, City of Paso Robles
- Chevron Tank Farm, City of San Luis Obispo
- Eagle Ranch, City of Atascadero

It is uncertain if these will be submitted next year, but planning and environmental work is being completed on each of these proposals. LAFCO Staff continues to monitor each project and provide comments at the appropriate times.

OTHER PROPOSALS

- Formation of Paso Robles Basin Water District The County will consider whether to submit an application to form a District to manage the Paso Robles groundwater basin. LAFCO has provided information to agencies and the public about how this process works and what are the next steps. An information guide has been prepared to help understand and clarify the formation process. Study Sessions have been completed.
- Fiero Lane Outside User Agreement-This proposal would allow properties in the Fiero Lane area in the City's Sphere of Influence to be served by the City and eventually lead to an annexation.

FOLLOW-UP ON APPROVED PROPOSALS

Several proposals were approved in 2014 and follow-up actions are being completed:

- The Heights to the City of Arroyo Grande-Complete the condition compliance phase of the approval including map resubmittal and open space easement approval by the City.
- Creekside Ranch Annexation-Complete the condition compliance phase by submitting and an easement that covers the areas indicated in the approval.
- **Dissolution of County Service Area 17**-Completion of the Protest Hearing Process. A protest hearing is scheduled for February 4, 2015.

SPHERE OF INFLUENCE/MUNICIPAL SERVICE REVIEW UPDATE

The Sphere of Influence (SOI) is a boundary that identifies areas a jurisdiction might serve over the next 20 years. The Municipal Service Review (MSR) provides information about a jurisdiction's ability to serve a particular area. The MSR is an informational document that summarizes the existing service situation of a jurisdiction. The Service Review compiles information that is provided by the jurisdiction to LAFCO.

Other information from the County Planning Department, State Controller's Office, County Auditor's Office, and other agencies is also used to prepare the SOI and MSR. LAFCO Staff reviews, summarizes and evaluates the various studies and data and prepares a Draft Sphere of Influence Update and Municipal Service Review. A Municipal Service Review is prepared in accordance with Section 56430 of the California Government Code. This code section was updated in 2012 to include seven factors instead of the previous six factors. The Service Review contains written determinations that address the following seven factors. Information and written determinations regarding each of the factors is provided in the Service Review and include:

- 1. Growth and Population projections for the affected area.
- Location and characteristics of any disadvantaged unincorporated communities
- 3. Present and planned capacity of public facilities and adequacy of public services, including infrastructure needs or deficiencies
- Financial ability of agencies to provide services
- 5. Status of, and opportunity for, shared facilities
- 6. Accountability for community service needs including governmental structure and operational efficiencies
- 7. Any other matter related to effective or efficient service delivery, as required by commission policy

LAFCO compiles a variety of information in preparing a Service Review. Also, administrative and organizational information is collected and evaluated. In order to complete a review LAFCO relies on Audit Reports submitted to the County Auditor Controller's Office pursuant to state law, original formation filing documents, State Controllers Special Districts Annual Financial Reports, the General Plan, Capital Improvement Plans, various studies and information from various websites.

CITIES

The 2014 Work Plan focused on those Cities which have passed, or are approaching the five-year requirement for update. In 2015, Staff recommends beginning the update process for the Cities of Morro Bay and San Luis Obispo. Several cities are considering development plans that may lead to future annexations. Below are the cities and the five-year update schedule:

Memorandum of Agreement (MOA). The MOA was developed between a City and County to improve communication and coordination in planning for future growth and development. Each City, with the exception of Grover Beach, has an MOA with the County. The Memoranda of Agreement between the City and County is reviewed and amended to reflect any changes to the Sphere of Influence and provisions that are agreed to by the County and City.

The second versions of the MOAs contain more detail about what type of development might be expected in the SOI. This helps clarify expectations and provides guidelines that help guide future projects in the SOI. The MOA has also been used to specify a particular planning process or policies for areas. Also the second versions address other issues such as water resources and agricultural/open space preservation.

DISTRICTS

The 2014 Work Plan focused on those Districts which have passed, or are approaching the five-year requirement for update. Staff recommends the schedule for updating the SOIs and MSR for the Districts be followed as shown in the table below.

MAPPING PROGRAM

LAFCO Staff (Mike Prater) continues to implement and improve LAFCO's Geographic Information Systems (GIS) mapping program. This program produces a number of important deliverables including the updated Service Areas and Spheres of Influence for all Cities, Special Districts, and County Service Areas in the County. Recently, LAFCO has been recognized by other agencies as the central keeper of boundary data. LAFCO is responsible for maintaining the boundaries for jurisdictions in the throughout the County. The Directory of Local Agencies contains maps and service information regarding these agencies and is updated every two years. The History of Annexations is an online inventory of all annexations. This inventory includes a summary map and the Certificate of Completion and Resolution. Maps are created for each annexation and Sphere of Influence Update considered by LAFCO. Mapping is a key piece of LAFCO's service capability. LAFCO Staff also participates in the Countywide GIS Committee and is helping to distribute GIS data to other jurisdictions.

CALAFCO ACTIVITIES

CALAFCO is LAFCO's statewide organization that provides educational opportunities, follows and facilitates the discussion of issues on a statewide basis. The SLO LAFCO EO serves as a Deputy Executive Officer for the CALAFCO Board of Directors and is also on the Legislative Committee. Last year he coordinated the CALAFCO University courses and this next year he will be the Program Chair for the CALAFCO annual conference. Staff and Commissioners have been involved in the continuing education process by participating in the annual CALAFCO Conference and attending the Staff Workshop.

December 3, 2014

Approximately 1:30 pm, Chair Luft calls the meeting to order.

- 1) Determination of a Quorum and Introductions Quorum established.
- 2) <u>Approval of November Meeting Minutes</u> The November 5, 2014 WRAC meeting minutes were reviewed and approved by the Committee upon a motion by Member Greening, and a second by Member L. Chipping (10-0-4).
- 3) Public Comment Member Greening reports the Oster Quarry project will be presented before the County Planning Commission on Thursday, December 11. Mr. Greening urges WRAC members to review and comment on the final environmental impact report (EIR). He states a Class II air quality particulate impact is included in the project, meaning no particulates may escape the site. Concern is expressed with respect to the amount and the origin of water required to achieve this goal. Mr. Greening also emphasizes uncertainty regarding the Philips 66 Track extension project. He mentions the draft EIR includes a Class I impact to water supplies due to the risk of oil spills during transportation. Nipomo resident, John Snyder, updates the Committee on the Santa Maria groundwater litigation. Member Lucey suggests the Committee become familiar with existing groundwater basin reports. Member L. Chipping reports that SLOCOG has released the Union Pacific Railroad (UPRR) Coast Corridor Improvements EIS/EIR for the Salinas to San Luis Obispo rail line. Ms. Chipping stresses the importance of Section 3.12, which summarizes the hydrologic and water resources impacts due to the current and proposed lines. Mr. Greening advises the Committee of a public hearing at Atascadero City Hall on January 7, at 8:30 am, where comments can be directed. Ed Eby, Nipomo resident, reports that LAFCO has published a formation guide, summarizing the process for the creation of a water district.

4) Ongoing Updates:

- a. Rain & Reservoir Report Courtney Howard, County Staff, informs the Committee that the state water project delivery allocation is now 10%. Ms. Howard notes this projection will be updated frequently through April.
- b. <u>Paso Robles Groundwater Basin Management Efforts</u> Ms. Howard reports the Paso Basin Advisory Committee will hold a public meeting to review the groundwater basin computer model update on Monday, December 8 at 6:30 pm at the Templeton Community Center. Additional refinement of the model update will be discussed before implementation. The public comment period will end on December 15. The

Board of Supervisors will be presented with the request for model refinement and the additional model runs on either January 6 or January 13. Ms. Howard mentions the water district application team is also working with the Clerk Recorder to create a timeline. Member Broadhurst questions if the groundwater monitoring well information is public. Ms. Howard responds that the county only monitors wells with landowner permission and the landowner can decide whether to allow information to be made public. Ms. Howard also notes that annual basin reports for the Santa Maria Groundwater Basin are available online.

c. Integrated Regional Water Management (IRWM) Program - Carolyn Berg, County Staff, informs the Committee the region received \$6.3 million in DWR drought grant funding, half of the original request. The District worked with the five original projects to develop recommendations regarding which projects will be funded. Ms. Berg advises that on December 2, 2015 the Board approved proceeding with developing a grant agreement that excludes the lowest scoring local projects which were the San Simeon project and Chorro Valley Intertie project. Member Greening asks about shortfalls in state water supply, whether Whale Rock water is available to meet some of those needs and Chorro Valley stakeholder meetings. Jill Ogren, County staff, responds that the meetings consist of representatives of all state water users in the Chorro Valley area. Mr. Greening proposes the Nacimiento Water Project Commission be included in these meetings. He mentions in the future it would be beneficial for a project seeking funding to define "emergency," the duration of an emergency, as well as the limits of an emergency. Discussion ensues regarding the IRWM grant competitiveness of projects sponsored by municipalities versus individual farmers/residents and smaller agencies/organizations that have limited financial resources for funding projects. Ms. Berg mentions a good place to address these concerns is at the next IRWM Regional Water Management Group meeting on January 7.

5) WRAC Administrative Items:

- a. <u>2015 WRAC Calendar</u> Ms. Howard notified the Committee that WRAC meetings will continue in the County Library Community room. Ms. Berg states the WRAC calendar is ready to view.
- b. Timing of Agency Member Nominations, At-Large Membership Confirmations, Board Appointments and WRAC Officer Ms. Berg requests a copy of the resolution from Agency Boards or Councils if there will be new or alternate members for WRAC appointments. Ms. Howard advises the Committee if there are At-Large representatives that would like to continue, there will need to be a formal reappointment of the position. If representatives would not like to continue, Ms. Howard requests notification in order to advertise and fill the vacancy. Member Luft suggests reaching out to Committee members that have been absent for more than three meetings. Ms. Berg informs the Committee that bylaws allow for members with three or more unexcused absences to be removed from the Committee.

- 6) Water Resources Advisory Committee's Review of Upcoming County Planning Water Programs:
 - a. Consider Forming an Ad Hoc Subcommittee to Review the County Water Neutral New Development Policies and Ordinances Michael Hanebutt, County Planning Staff, gives a presentation on County Water Neutral New Development and Agricultural Water Waste Prevention to protect water resources. Water Neutral New Development calls for changes in the general plan, specifically to Agriculture and the Conservation and Open Space elements. Additional ordinance changes include Title 5, Title 19, and Title 8. An environmental impact report is to be released by the end of the year, followed by a 60 day public comment period. Discussion ensues on the clarity of the word "waste" and how a definition will be determined. Mr. Hanebutt states the Planning Commission will hear the proposed policies/ordinances in May and go to the Board of Supervisors in June. Draft materials on Water Neutral New Development will be available for WRAC review by the end of the year and draft materials for Agricultural Waste Water will be available early January.
 - b. Consider Forming an Ad Hoc Subcommittee to Review Agricultural Water Waste Prevention Ordinance Member Garfinkel moves to form two Subcommittees, one to consider both ordinances from an agricultural perspective and one for the residential perspective, with a second by Member Walters (16-0-3). Member Luft suggests Subcommittees convene to appoint a Subcommittee chair and report back to Ms. Howard.
- (CASGEM) Jill Ogren, County Staff, provides a presentation on CASGEM, including the program's goal of understanding seasonal and long term trends of groundwater basin levels state-wide, the need to reconcile groundwater basin boundaries in DWR Bulletin 118 with groundwater basin boundaries as defined by local studies, program well information requirements, as well as CASGEM benefits and impacts on future groundwater management and outreach efforts. Member Greening questions if conservation efforts can be triggered due to well level information acquired through CASGEM. Ms. Howard mentions triggers and data used would be identified in each basin's groundwater sustainability plan. She informs the Committee of the January WRAC meeting, where a discussion on the strategic approach to the Sustainable Groundwater Management Act (SGMA) will take place. Discussion ensues on whether a monetary incentive should be used to encourage well owners to participate in CASGEM. Discussion arises regarding well information confidentiality issues. Ms. Howard notes that the District is moving forward with being the single monitoring entity for all the basins until other entities come forward.
- 8) <u>Suggested Future Agenda Items</u> Topics requested include: Los Osos CSD and Golden State Water Company status update on Los Osos groundwater basin; Presentation of initial approach to SGMA; and, Overview of the Public Works Department internal restructuring.



Recommendation

Receive a Presentation on the Water Supply, Water Systems, and Wastewater Systems chapters of the 2012-2014 Resource Summary Report (RSR) of the Resource Management System (RMS) and provide comments prior to February 6, 2015.

Discussion

Overview of the RMS

The RSR is one of the key parts of the Resource Management System (RMS), which is described in Framework for Planning, Part I of the Land Use Element of the County General Plan. The RMS provides information to guide decisions about balancing land development with the resources necessary to sustain such development. To accomplish this goal, the RMS focuses on:

- · Collecting data
- Identifying problems; and
- Helping decision-makers develop solutions.

When a resource deficiency becomes apparent, several courses of action are possible to protect the public health, safety and welfare:

- The resource capacity may be expanded;
- Conservation measures may be introduced to extend the availability of unused capacity;
- Resource efficiencies may be introduced;
- Development may be restricted or redirected to areas with remaining resource capacity.

In this way, the RMS addresses development in terms of appropriate distribution, location, and timing rather than growth versus no-growth.

What's New In this Resource Summary Report?

In addition to providing an updated analysis of the various resources and recommended Levels of Severity, the 2012-2014 RSR differs from the 2010-2012 RSR in a number of important aspects:

- The discussion of resources and Levels of Severity is organized by resource, rather than by community and region.
- The RSR includes many more maps and illustrations where necessary for geographic context, including the boundaries of major water purveyors.

• The RSR includes new criteria used for assessing Levels of Severity, as well as recommended actions, as adopted by the Board of supervisors in December 2014 (as part of the revisions to the RMS). In particular, the Board adopted many of the WRAC's recommendations, including extending the lead times for water supply. In addition, they adopted changes to the lead times for wastewater to correspond to the established times used by the Regional Water Quality Control Board. These new criteria have resulted in additional recommended LOS IIIs for water supply.

Project Status

Staff is currently reviewing the water supply, water system, and wastewater systems chapters and will provide draft copies to the WRAC prior to the January 7, 2015 meeting. The RSR is scheduled for the Board of Supervisors in March 2015. WRAC comments would need to be received by February 6, 2015 in order for them to be included and evaluated in the staff report to the Board of Supervisors.

Recommendation

Receive a County Implementation Strategy on the Sustainable Groundwater Management Act (SGMA)

Discussion

California Senate Bills 1168 and 1319, and Assembly Bill 1739, signed by the Governor in September 2014, together comprise the "Sustainable Groundwater Management Act" (SGMA). SGMA is ground breaking in that it requires local agencies to manage groundwater "...in a manner that can be maintained during the planning and implementation horizon without causing undesirable results". SGMA, which took effect on January 1, 2015, provides for the preparation and implementation of Groundwater Sustainability Plans for all water basins in the State², with High and Medium priority basins placed on a statutory schedule for identification of a Groundwater Sustainability Agency/Agencies (GSA), development of a Groundwater Sustainability Plan/Plans (GSP), and achieving sustainability. Based on the 2014 Final Basin Prioritization by the State Department of Water Resources (DWR), there are five high and medium priority groundwater basins mapped in San Luis Obispo County:

- 1. Paso Robles (High)
- 2. Santa Maria (High)
- 3. Los Osos (High)
- 4. San Luis (Edna) Valley (Medium)
- 5. Cuyama Valley (Medium)

Implementation of SGMA will involve all public agencies, private water companies, and landowners concerned with the management of groundwater in San Luis Obispo County. Although SGMA specifies that local public agencies are the key members of a GSA, stakeholder outreach requirements, coordination requirements, and the practical realities of preparing a Groundwater Sustainability Plan, require the involvement of the entire community.

Therefore, staff will present an SGMA Implementation Strategy to the Board of Supervisors on January 13, 2015 for their consideration and adoption.
