GENERAL MANAGER'S REPORT

ITEM

Standing report to your Honorable Board -- Period covered by this report is January 21, 2016 through February 5, 2016.

DISTRICT BUSINESS

Administrative

- On July 2, 2015, supplemental water deliveries from the City of Santa Maria commenced via the Nipomo-Santa Maria Intertie pipeline. Since that time, an average of 410 gallons of water per minute has been imported. The District is on track to deliver 645 acre feet (210 Million Gallons) of supplemental water this fiscal year.
- On May 20th, the Nipomo Mesa Management Area (NMMA) Technical Group reported the Spring 2015 Key Wells Index is in Severe Shortage conditions. As a result, NMMA public water purveyors (NCSD, Golden State WC, and Woodlands Mutual WC) are required to reduce groundwater production by 30%. All three entities have consistently met this goal since July 2015.
- On May 21st, the District enacted Stage III Shortage conditions and ceased accepting application for new water service.
- Governor's Executive Order B-36-15, November 18, 2015, modifications to Executive Orders B-26-14, B-28-14, and B-29-15.
- As a result of customer conservation efforts, District water production is significantly lower in 2015 compared to previous years. Customers finished the year strong with December 2015 total water production being 37.5% less than December 2013. The cumulative reduction in total water production since State-ordered conservation in June 2015, is 32.9%. The District's State-mandated reduction goal is 28%, month to month and cumulative. Thanks to the completion of Nipomo Supplemental Water Project Phase 1, the District's reduction in groundwater pumping is even more significant. December 2015 groundwater production is 48% lower than the District's five year average. Even though the District imported water for only half of 2015, the total groundwater pumped in 2015 is 32% lower than the five-year average.
- The District encourages residents to provide reports of any observed water waste. Staff follows up each report with phone calls and written notice to customers when warranted. During January 2016, staff responded to 3 reports of water waste.
- In January 2016, staff proactively hung 28 door hangers on accounts where the billing meter read showed irregularly high water usage.

- San Luis Obispo County maintains two rain gauges in the area. One is located at the District's Southland Wastewater Plant (Nipomo South) and one at the District's Tefft Street water storage site (Nipomo East). In the past month, Nipomo South gauge recorded approximately 1.1 inches of rain and Nipomo East reported 1.5 inches of rain. The seasonal rain total for Nipomo South is 6.5 inches. Average rainfall for this gauge is 16-inches per year. The seasonal total for Nipomo East is 8.1 inches. Average rainfall for Nipomo East is 18-inches per year.
- During January the District issued 2 leak adjustments totaling \$94 in discounts.





Customers Continue to Meet Conservation Goals

The District's conservation efforts remain strong and exceed the State's mandated 28% reduction.

In December, the District produced 111 acre feet or about 36 Million gallons of water to meet customer demand. This equates to a **37.5**% reduction in overall production compared to December 2013 - the greatest reduction this year. Additionally, thanks to the arrival of supplemental water in July, groundwater pumping during December was **48**% lower than the 5-year average for December. Good job, Nipomo!







RECEIPT OF BIDS: Sealed Bids will be received at the office of the General Manager, Nipomo Community Services District, OWNER of the WORK, located at 148 South Wilson Street, Nipomo, CA 93444, until 2 PM, local time, on February 25, 2016, for SUPPLEMENTAL WATER PROJECT JOSHUA ROAD PUMP STATION RESERVOIR. Any Bids received after the specified time and date will not be considered. Bids shall conform to and be responsive to the Contract Documents for the work.

OPENING OF BIDS: The Bids will be publicly opened and read at 2 PM, local time, on February 25, 2016, at the above-mentioned office of the OWNER.

COMPLETION OF WORK: The WORK must be completed within 270 successive calendar days after the commencement date stated in the Notice to Proceed.

DESCRIPTION OF WORK: The work involves construction of a partially buried 500,000 gallon prestressed circular concrete reservoir, approximately 120 LF of 24-inch ductile iron pipe, valves and fittings, and associated electrical, instrumentation and controls improvements.

SITE OF WORK: The project site is located at the District's Joshua Road Pump Station, 805 Alta Vista Way, in Nipomo, California.

PREQUALIFIED CONTRACTORS: The District has prequalified general contractors, reservoir constructor subcontractors, and reservoir prestressor subcontractors for this project. Only general contractors, reservoir constructor subcontractors, and reservoir prestressor subcontractors who have been prequalified can participate in bidding for the contract to construct the Project. Bidders must register as an Official Plan Holder at ASAP Reprographics and pay \$55 (non-refundable) for each set of Contract Documents (including technical specifications and accompanying reduced scale drawings) to be

assured of receiving all addenda and plan revisions that may occur during the bidding. Checks shall be made payable to the Nipomo Community Services District. The scale of the reduced drawings is about one-half of the original scale. If full scale drawings are desired they may be purchased at reproduction cost from ASAP Reprographics. BID SECURITY: Each Bid shall be accompanied by a certified or cashier's check or Bid Bond in the amount of 10 percent of the Total Bid Price payable to the Nipomo Community Services District as a guarantee that the Bidder, if its Bid is accepted, will promptly execute the Agreement and provide all required bonds and insurance. A bid shall not be considered unless one of the forms of Bidder's security is enclosed with it.

CONTRACTOR'S LICENSE CLASSIFICATION: In accordance with the provisions of California Public Contract Code Section 3300, the OWNER has determined that the CONTRACTOR shall possess a valid Class "A" General Engineering contractor's license issued by the State of California, Contractors State License Board, at the time that bids are submitted. Failure to possess the specified license shall render the Bid non-responsive and shall bar award of the Contract to any bidder not possessing the license at the bids are submitted.

BIDS TO REMAIN OPEN: The Bidder shall guarantee the Total Bid Price for a period of 90 calendar days from the date of bid opening.

BASIS OF AWARD: The OWNER will award the contract, if at all, to the responsible contractor that submits the lowest bid. The low bid will be determined based on the sum of the Base Bid and Additive Bid Items 18 and 19.




PRESIDENT'S MESSAGE

Board Authorizes Bidding for Supplemental Water Project Joshua Road Pump Station Reservoir

At its January 27th Regular Meeting the District's Board of Directors authorized staff to advertise the Supplemental Water Project Joshua Road Pump Station Reservoir for bidding.

The Nipomo Supplemental Water Project delivers water purchased by the District from the City of Santa Maria and allows the District to reduce pumping from existing wells to slow the depletion of groundwater and reduce the potential for seawater intrusion on the Nipomo Mesa. The Project also increases the reliability of the District water supply by providing an additional source other than groundwater. Construction of Phase 1 was authorized by the Board in June 2013 with the first delivery of water commencing on July 2, 2015. Phase I is scheduled to be completed in February 2016.

The Supplemental Water Project Joshua Road Pump Station Reservoir will consist of construction of a 500,000 gallon partially-buried concrete reservoir at the Joshua Road Pump Station along with the related piping, electrical, instrumentation, grading, and landscape improvements. The Project will increase delivery capacity to at least 800 AFY and provide operational flexibility.

In November 2015, the Board adopted Resolution 2015-1397 that established a project specific pre-qualification policy for the Supplemental Water Project Joshua Road Pump Station Reservoir. The list of general contractors and selected subcontractors that have pre-qualified to submit bids for the Project is available on the District's website.

The Board is tentatively scheduled to consider awarding the Project construction contract in late March 2016.

Most meet water conservation targets

communities in San Luis Obispo County met their water conservation targets for December, according to new data released Tuesday by state water regulators.

Unlike the month of November, when all local water suppliers met targets, in December the city of Paso Robles and the Atascadero Mutual Water Co. narrowly missed statemandated goals, according to reports provided by the State Water Resource Control Board

Statewide, water conservation in December fell to 18.3 percent compared with December 2013 usage — below the state's 25 percent conservation target for the third straight month. On the Central Coast, the water conservation rate in December was 24.7 percent, according to a fact sheet from the water board.

The average statewide water use declined from 76 gallons per person per day in November to 67 gallons in December, the second lowest perperson rate since wateruse reporting began in June 2014.

Since June 2015, all cities and water suppliers in San Luis Obispo cumulatively beat their conservation goals when compared with water use for the same period in 2013. The cities and water suppliers surveyed are the Atascadero Mutual Water Co., Arroyo Grande, Cambria Community Services District, Morro Bay, Nipomo Community Services District, Paso Robles, Pismo Beach and San Luis Obispo.

Data for Grover Beach, which is also tracked by the state, was not reported to state water regulators for December.

Statewide, Californians cut their water use by a combined 25.5 percent over the past seven months. This equates to about 354.2 billion gallons of water saved — enough to provide 5.4 million Californians with water for a year, state water regulators said.

While the state has received some desperately needed rainfall, water board officials continue to urge residents to conserve as much as they can through the winter.


"While the recent rains and growing snowpack are wonderful to behold, we won't know until spring what effect it will have on the bottom line for California's unprecedented drought," Felicia Marcus, chair of the State Water Resources Control Board, said in a news release. "Until we can tally that ledger, we have to keep conserving water every way we can."

In April 2015, Gov. Jerry Brown mandated a 25 percent water use reduction for cities and towns across California. The state's water conservation regulation requires the state's larger urban water suppliers to save a targeted amount of water between June 2015 and February 2016, when the mandates expire.

State water board staff will reassess compliance based on the supplier's cumulative savings since June 2015, compared with the same time period in 2013.

The state water board was scheduled to meet Tuesday to consider whether to extend the restrictions through October 2016. In draft revised water conservation targets, the only community in San Luis Obispo County to possibly see its standard reduced is Paso Robles, which could drop to 24 percent from 28 percent.



Michael LeBrun officially retired as the Nipomo Community Services District general manager Friday and, to hear him tell it, it's an ending that is long overdue.

"I knew coming back (in 2011), when I went to permanent again, that for me, I wasn't going to make 10 years," LeBrun said. "I honestly did not see myself making it five years. ... But you know, we've hit some hurdles, and there is never a good time to go. It's not a good time now, there's always stuff. But I know in my heart of hearts that this is time."

After two separate stints as interim general manager and two as the permanent general manager — for a total of nine years with the district — LeBrun signed off this week after training his replacement, Mario Iglesias.

LeBrun first came to the district in 2004 from the Regional Quality Control Board, where he was a senior engineer. He stayed with the district for a year and a half before stepping down to make way for a general manager who would be able to start several major public works projects the district needed, he said.

Over the next five years, LeBrun would twice be chosen to act as interim general manager while the district cycled through other general managers before ultimately being hired for the permanent position for a second time in June 2011.

His time with the district was filled with successes the district's highly contested \$17.5 million supple source of water to the town beyond its groundwate and other delays. The most notable mix of both success and challenge was e project that moved water from Santa Maria to Nipomo and provides a se of the project was completed in July 2015 after years of legal setbacks LeBrun announced his plans to resign.

LeBrun said some of his other accomplishments during that time included upgrading a \$13 million wastewater treatment plant and helping the district through one of California's harshest droughts on record. He's especially proud of the district's staff, most of whom he personally hired.

"I will forever be able to point at the work I've done in the last five years and take pride in what I've done here with the community, and those projects," he said. "But the real legacy lives on in the staff that we've instilled these ideals in. And then bringing a man like Mario in, who I assure you, is capable to continue them."

Iglesias doesn't seem fazed to be taking over the district's leadership Monday.

"I've got this all under control, and Michael is just going to ride into the sunset," he said with a laugh as he and LeBrun sat down with The Tribune to talk about the changing of the guard.

The Monterey native comes to the district from Morgan Hill, where he worked as the utility systems manager for close to a decade. Before that, he was general manager of the Aromas Water District for five years.

MORGAN HILL, LOCATED NORTH OF GILROY, HAD A POPULATION OF 41,179 AND APPROXIMATELY 12,900 WATER HOOKUPS IN 2015. THE AROMAS WATER DISTRICT, LOCATED NORTH OF SALINAS, HAD APPROXIMATELY 929 WATER HOOKUPS THAT SAME YEAR.

At both sites, Iglesias said he learned what it means to be a public servant.

"It's one thing to go to work and do your job," he said. "But realistically, you have to keep that overarching idea and ideals that you're not just an employee. You aren't just a person picking up a paycheck. You are, in order to succeed in this, you really have to be able to commit wholly."

Iglesias said among his top priorities as general manager will be to continue to build out the supplemental pipeline project and to keep LeBrun's forward momentum going while improving the district office and bolstering its staff.

"He's really been able to take that synergy, that greater-than-the-individuals idea, and kinda build on that and get that wave of success built into the organization so that they really have a belief in themselves that they can achieve," Iglesias said of LeBrun. "So what do I do from here? I try to keep that wave going."

He also said he plans to become a visible member of the Nipomo community by buying a house in town and joining several local boards and groups, though he said the latter will have to wait until he's fully settled into his role.

Given his long work hours so far, he said, joking, "I know what my office looks like, and I know what Nipomo looks like predawn."

The American Public Works Association's (APWA) California Central Coast Chapter has recognized the Nipomo Community Services District's Supplemental Water Project as the local Public Works Project of the Year award recipient. The Nipomo Supplemental Water Project Phase 1 (Project) is a \$17.5 million project which includes funding from a \$2.2 million State of California Department of Water Resources Grant. The Project facilitates interconnection of four regional water providers and the importation of developed water from the City of Santa Maria to the Nipomo Mesa Management Area. The Project increases Nipomo's water resources and supply reliability for generations to come. Selected for its uniqueness, the project overcame countless construction issues related to the difficult site conditions, including sink holes that nearly resulted in the loss of the horizontal boring equipment.

The Supplemental Water Project will be submitted for National APWA award consideration in March of 2016. Other cities receiving awards include the City of Paso Robles for the Park 'n' Ride Parking lot and Union Road Bike Lanes, and the City of San Luis Obispo Water Resource Recovery Facility Energy Efficiency Project. The Professional of the Year was awarded to Ditas Esperanza, Capital Projects Engineer for the City of Paso Robles.

State Water Board Adopts Extended Emergency Water Conservation Regulation

Extended Regulation Gives More Flexibility to Water Suppliers to Meet Conservation Targets

SACRAMENTO – With California still experiencing severe drought despite recent rains, the State Water Resources Control Board (State Water Board) today adopted an extended and revised <u>emergency regulation</u> to ensure that urban water conservation continues in 2016.

The regulation extends restrictions on urban water use through October 2016 while providing urban water suppliers more flexibility in meeting their conservation requirements. It also directs staff to report back on additional flexibility once more complete water supply information is known in April. The action follows Governor Edmund G. Brown Jr.'s Nov. 13, 2015, Executive Order directing the State Water Board to extend the emergency water conservation regulation should drought conditions persist through January 2016.

"After four years of extreme drought, there is still a need for Californians to keep up their stellar conservation practices," said Felicia Marcus, chair of the State Water Resources Control Board. "This updated regulation acknowledges that need, while making adjustments in response to feedback from water suppliers and others. If we continue to receive a lot of rain and snow in February and March, we may scale back the conservation requirements further, drop them, or move to another approach."

Under the revised regulation, statewide water conservation is expected to exceed 20 percent compared to 2013 water use. The revised regulation responds to calls for greater consideration of certain factors that influence water use in different parts of the state, including hotter-than-average climate, population growth, and significant investments in new local, drought resilient water sources such as wastewater reuse and desalination.

Due to the severity of the water deficits over the past four years, many of California's reservoirs and groundwater basins remain <u>depleted</u>, and the need for continued water conservation persists. Today's action serves as the fourth iteration of the emergency regulation since the State Water Board first instituted statewide conservation requirements in July 2014.

The State Water Board will continue to track water conservation efforts for each of the state's urban water suppliers (those with more than 3,000 connections) on a monthly basis. Compliance with individual water supplier conservation requirements will continue to be based on cumulative savings since June 2015. Cumulative tracking means that conservation savings will be added together from one month to the next, including conservation achieved under the Board's May 5, 2015, emergency regulation, and compared to the amount of water used during the same months in 2013.

Summary of Conservation Regulation Adjustments

The updated emergency regulation continues to specify how much water communities must conserve based on their residential gallons per capita per day (R-GPCD) data (from July through September 2014), and provides recognition for certain factors affecting water use, along with other changes detailed below:

- Credits and adjustments to urban water suppliers' conservation standards are now available. They range from 2 percentage points to a maximum of 8 percentage points. In some cases, water suppliers are automatically credited based on conditions in their service areas. In other cases, water suppliers must supply specific information to support and determine the size of an adjustment.
- The regulation provides credits in three ways:
 - 1) Considering the differences in climate affecting different parts of the state;
 - 2) Providing a mechanism to reflect water-efficient growth experienced by urban areas; and
 - 3) Recognizing significant investments made by suppliers toward creating new, local, drought-resilient sources of potable water supply.
- The regulation creates penalties for homeowners' associations or community service organizations that block, stifle or threaten homeowners from reducing or eliminating the watering of vegetation or lawns during a declared drought emergency in violation of existing law.

This regulation extends the original framework that has resulted in a statewide water conservation rate of 25.5 percent over a seven-month period, according to <u>December conservation</u> data released earlier today. Even assuming all of the 400-plus water agencies receive the applicable credits offered in this regulation, the statewide cumulative conservation rate is still projected to exceed 20 percent.

"We expect a savings rate greater than 20 percent, but perhaps not quite achieving the prior call for 25 percent," said Marcus. "We anticipated this might occur with any tweaks to our existing regulation. This regulation should still allow this state to save more than 1 million acrefeet of water through October 2016 – which is enough water to serve an average of two million California families. While we are hopeful that we are turning the corner on this drought, the

truth is that it's just too soon tell. Any additional water we can conserve to today will serve us well tomorrow if the drought continues."

Next Steps

The regulation will now be submitted to the Office of Administrative Law, which will review and approve or deny the regulation. If approved by the Office of Administrative Law, the regulation will take effect immediately and remain in effect for 270 days from the approval date.
