# **SPECIAL MEETING MINUTES**

## FINANCE AND AUDIT COMMITTEE

### 1. CALL TO ORDER, FLAG SALUTE AND ROLL CALL

## 3. REVIEW DRAFT REQUEST FOR PROPOSAL (RFP) FOR AUDIT SERVICES
