

Stage IV Water Shortage Conditions

Stage III conservation measures still in effect

Following an announcement from the Nipomo Mesa Management Area (NMMA) Technical Group regarding area key wells (see graph below), District Board of Directors declared a Stage IV Water Shortage in accordance with its Water Shortage Response and Management Plan (WSRMP). The Board directed staff to continue enforcing Stage III actions of the WSRMP, and not impose additional Stage IV actions until further review of the community's conservation efforts at a January 2017 Regular Board Meeting.

Ensuring Water Supply Reliability for Nipomo

Stage IV continued...

The District's Water Shortage Response and Management Plan

The Water Shortage Response and Management Plan is based on five escalating stages of drought. In Stages III through V, there are targeted reductions in water use designed to protect long-term groundwater supplies.

In May 2015, the Board declared a Stage III water shortage, urged customers to reduce their usage by 30%, and halted all new applications for service. Over the past year, groundwater pumping decreased which helped the basin recover slightly. However, the basin remained in Severe criterion for a second year prompting a Stage IV water shortage. The District's Stage IV sets a District-wide groundwater use reduction goal of 50%.

The District is working with neighboring water agencies and County agencies to coordinate conservation efforts across the Nipomo Mesa. Importing more supplemental water and cutting water use is critical for overall basin health and to keep groundwater levels from falling below sea level, possibly causing a condition that could contaminate the water supply.

Thanks to customers' conservation efforts and the arrival of supplemental water in July 2015, the District has seen a 46% reduction in groundwater pumping to date. With this current reduction rate, the Board is confident the District, through the community's continued conservation effort, can achieve the 50% groundwater reduction goal thus holding off further action (see conservation recommendations to the right).

The Nipomo Supplemental Water Project received its first deliveries of water from Santa Maria in July 2015. As of June 30th the District had imported 671 AF (acre feet) to the Nipomo Mesa area.

In March the District began construction on Phase IIA of the Supplemental Water Project which includes a 500,000 gallon reservoir for the importation of a minimum of 800 AFY of water from the City of Santa Maria. The Project is scheduled to be completed by January 2017.

This increase in supplemental water allows the District to pump less groundwater from the underlying aquifer and ensure water supply reliability.



Answers to Frequently Asked Questions

Conservation Still Encouraged

The District's conservation efforts dipped a bit in July but overall are strong. The District produced 203 acre feet or about 66 Million gallons of water to meet customer demand. This equates to a 25.3% reduction in overall production compared to July 2013 and a 30.2% average reduction for the year.

Thanks to the arrival of supplemental water in July 2015, groundwater pumping during July 2016 was 52.3% lower than the 5-year average for July!

With the Board's declaration of Stage IV water shortage conditions in July, the District continues to encourage customers to conserve as they have. There are no specific mandated restrictions added to Stage III requirements. The Board directed staff to keep Stage III conservation measures in place (see below) until further review of pumping levels at a January 2017 Regular Board meeting. If the 50% groundwater reduction goal is not met, the Board may decide to implement Stage IV conservation measures. Keep up the good work, Nipomo!

Minimum irrigation to preserve high-value andscape. Irrigate after 8PM and before 9AM

Do not allow excessive runoff

Do not use water to wash vehicles or equipment except for health and safety purposes

Do not use water on exterior surfaces
