GENERAL MANAGER'S REPORT

<u>ITEM</u>

Standing report to your Honorable Board -- Period covered by this report is August 10, 2013 through September 5, 2013.

DISTRICT BUSINESS

Administrative

- Southland Wastewater Treatment Plant Improvement Project continues on schedule and within budget. The July 2013 construction report is attached.
- Initiation of Supplemental Water Project Phase 1 continues to demand significant staff time. The Project is proceeding on schedule.
- On September 5, 2013, the CDARS (Supplemental Water Funds) at Mission Community Bank matured. The balance was \$924,699.29. The funds were wired from Mission Community Bank to Rabobank. On September 6, 2013, the District wired the funds to LAIF. The funds are now liquid and can be used to pay supplemental water project progress payments.
- Received five proposals for Water Rate and Capacity Charge Study under staff review, scheduled for consideration by Finance and Audit Committee on 9/12/13.
- Circulated and posted a request for Strategic Planning facilitator responses due 3PM, Friday, September 20, 2013.
- Rejected damage claims made by original developer of a project formally known as Maria Vista Estates (see attached).
- Issued contracts for Supplemental Water Project, Bid Package 3 (Blosser Road Pipeline) to Specialty Construction, Inc.
- Issued contracts for Supplemental Water Project, Bid Package 4 (Pump station, well head improvements) to Spiess Construction Co., Inc.
- Provide SLO County Board of Supervisors written Board comments on Laetitia Agricultural Cluster EIR.
- Recruitment for Wastewater Supervisor, Utility Operator, and Customer Service vacancies continues. All application periods closed, exams and interviews scheduled.
- The District has granted bill relief due customer water leaks on nine occasions since your Board adopted the new policy last winter. Approximately \$5,000 of revenue has been 'written-off' by granting this relief. The amount of relief to an individual customer ranges from \$120 to \$1,700 dollars. Two of the nine allowances are over \$1,000.
- Most recent data from Nipomo area County rain gauges recorded no rain during the past two weeks. County rain gauges are reset on July 1 each year. The Nipomo South gauge (Sensor 730) measured total rainfall for the year of 7 inches, 44% of the 16-inch annual average. The Nipomo North gauge (Sensor 730) measured 5.9 inches for the

past year, 33% of the 18 inch annual average. Twitchell Reservoir reports 0.0% capacity (at gauge minimum); Lopez Lake stands at 64.3% capacity (31,759 Acre-feet).

Progress Summary

General Site Work - Piping and Electrical

Summary of Work:

Cushman installed the 6-inch DR piping along the west side of the Sludge Drying Beds and the 6-inch TWAS and 6-inch NPW (non potable water) piping along east side of Sludge Drying Beds. They also installed the 3-inch NPW line between the Sludge Drying Beds and completed installation of the 4-inch DR laterals from Sludge Thickening System and the Sodium Hypochlorite Building which connect to the 6-inch DR pipe. Cushman began work on installation of the concrete pads at the ponds, installing the 18-inch pipe inlet structure slab for Pond 1. Bergelectric received several pull box vaults and installed Pull Boxes #11, 22 and 25. They also excavated for the duct banks and installed conduit between the pull boxes, then placed red slurry over the conduit.

























Board of Directors Award Supplemental Water Project Contracts

On June 20, 2013, the Board of Directors awarded \$14.5M in construction contracts and \$2M in construction related contracts for the Supplemental Water Project Phase I. This award of contracts is the 'beginning of the Mesa and on the south side end' for the District's 20vear quest to obtain a secand source of water to supplemental its groundwater only supply. The project will construct a water line interconnecting the District's water system with that of the City of Santa Maria. The project is expected to be complete by late 2014. Following completion of the pro-

ject, the District will purchase a portion of its water from the City. Construction is now underway. In the coming months, drilling activities will take place on the south end of the ee. A 2,600 foot long pipe

of the Santa Maria River levwill be installed under the river using horizontal drilling methods which greatly reduce the impact within the river bed environment. Construction crews will also be working along Blosser Road in the City of Santa Maria installing a mile of 24-inch water line to connect with

the City's main water infrastructure.

The project is being financed by a \$2.2M grant from the State and \$14.3 million in District funds both reserves and bond funds secured by District water rates and property tax income. The District has spent nearly \$4M developing the project since 2005. The funds for developing the project came from supplemental water charges collected from new customers added to the District's system since 2005.

Update on Southland Wastewater Treatment and Reclamation Facility Upgrade

Construction is now approximately 50% complete on a significant upgrade to the District's Southland Wastewater Treatment and Reclamation Facility. Once the project is complete it will replace the current pond-based plant and provide advanced



treatment and improved plant discharge quality.

At the July 10th Board meeting, the District's Board of Directors authorized the General Manager to approve a change order in the amount of \$876,900 with Cushman Contracting Corporation for the construction of additional disposal facilities as part of the ongoing project. The District awarded the project's \$10.2M construction contract to Cushman Contracting Corpora-

tion in June 2012. Project bid documents included an additive alternate bid item for additional on-site disposal facilities. To date, anticipated Project costs are well within budget, allowing the District sufficient funding to construct the additional disposal facilities. The expansion of disposal facilities will provide additional surface area for disposal of highly treated plant discharge and increase the onsite disposal capacity by more



than 100,000 gallons per day, adding years to the useful life of 'on-site' disposal facilities. The expansion gives the District additional time to develop off-site disposal facilities to meet the future needs of the Nipomo community.

Dan't flush the wipes! - Where to Dispose Household Items

Many household products do not dissolve (nondegradable) and are detrimental to not only a home's pipes but also the public sewer system's pipes.

When nondegradable wipes (including baby wipes, cleaning wipes, and rags) are flushed they bind together to form extremely long ropes and plug the sewer pipes (as shown in the pictures to the far right).



When disposing of the wipes, please throw them in the trash can or purchase wipes that will dissolve (are degradable).

Being mindful of what you flush down the toilet can save you a plumbing bill and also help save your community's sewer system. It takes several hours and is costly to unplug the sewer system from items such as wipes.



Don't Tamper with Water Meters—Just Call the District!

Water meters are an important tool for understanding and monitoring water use. Water meters belong to the District and tampering with the meter can lead to fines.

From time to time you may need to turn off your water due to an emergency. If you must do this, look for a valve located on the



Call the District for help. The District will send a worker out to turn off your meter, at no charge.

outside of your home where the water line goes into the house. Your sprinkler systems may have a separate valve.

The District's water meter box (shown in picture) should only be accessed by District staff if your own valves do not work. The District water meter valve requires a special tool.

Frequently Asked Questions

What is a water service charge?

The charge shown on your bill is the service charge for having water service available at your connection 24 hours per day, 7 days per week, 365 days per year.

What is the Sewer charge?

The Sewer charge shown on your bill is the service charge to pay for operating the sewer collection system, treatment plant and safe reintroduction of treated waste water back into the environment.

Who fixes a leak?

NCSD maintains the entire water system up to and including the water meter. It is the customers' responsibility to fix any water leak that happens after the water meter (customer side of meter).

MANAGER'S MESSAGE

The cost of providing a safe and reliable water supply to our customers continues to increase. We are scheduled to see increases (on the order of 9%) again in each of the next two years. If there is 'good news' here, it is that NCSD water rates remain some of the lowest in our area and our County. See our website (www.ncsd.ca.gov) to review a comparison of local water rates recently completed by Atascadero Water Company. Many District customers could actually lower their water bills even as our rates continue to increase. What is the secret? CONSERVATION; A typical customer uses more than ½ the water they purchase annually to water landscape. Most landscapes are over-watered. Saving water in your yard does NOT necessitate a 'dust-bowl' approach. Many 'drought tolerant' plants need little or no supplemental water once established. Most landscapes with a modest area of lawn along with native/drought-tolerant trees and shrubs can be kept happy and beautiful year round with very little irrigation.

Can you imagine going a week or a month without television, phone or Internet? How about no gas or electricity to heat your home in the coldest winter month?

Those scenarios are certainly not desirable, but for most of us, they would be survivable.

Now, consider a month without water or sewer service. Not a pretty thought and not even doable. Many often take water and sewer service for granted.

Water makes up two-thirds of a typical human's weight. Without water, the human body will begin shutting down nonessential functions within 24 hours. Death from dehydration can occur in as few as three or four days.

No water for your home landscape or our community landscape would severely impact property values. No water to fight fires would be disastrous.

Sewer collection and treatment systems are every bit as important as water to an urbanized community like Nipomo.

It was an outbreak of disease related to fecal contamination of private wells that led to the formation of Nipomo Community Services District back in 1965.

According to <u>water.org</u>, worldwide, a child dies every 21 seconds from water-related illness, and a majority of illness is due to fecal matter contamination of the water supply.

Efficiently managed and maintained water and sewer systems are vital to a community's health and livelihood.

NCSD's mission is to provide its customers with reliable, quality and cost-effective services now and in the future.

Since the district is a "customer-owned" local governmental organization, our customers and property owners play a critical role in keeping the district's operation sound.

NCSD is a stand-alone local government agency. We are not associated with or controlled by the county, state or federal government.

Our customer/owners control the operation through the election of five directors who serve on the governing board and set district policy and direction.



Trio of Nipomo residents apply for vacant seat

A trio of Nipomo residents are vying to replace the late 4th District Supervisor Paul Teixeira, joining three others from Arroyo Grande who are also hoping to be appointed to the vacant seat.

Former Nipomo Community Services District board member Michael Winn, Jim Harrison, current NCSD board president, and Jacqueline Frederick, local attorney and founding member of the Olde Towne Nipomo Association, have applied.

Although it's more likely than not that others have also applied for the vacancy on the San Luis Obispo County Board of Supervisors, Gov. Jerry Brown's office won't release any of the candidates' names nor confirm or deny the number of applicants.

Brown is expected to appoint a replacement supervisor to fill Teixeira's seat for the remainder of his term, although it's unknown how long the process will take.

Whoever is selected by Brown to fill Teixeira's seat, which became vacant after he died from a heart attack at the end of June, will serve out the remainder of his term. The person would need to run for election to retain the job for another four-year term.

Winn, who confirmed he applied for the position, is already organizing a campaign team and would seek election if he was appointed to the board, he said.

"You would be nuts not to plan to run for a full term," Winn said. "What can you get done in 15 months? I'm definitely running for a full term. That's part of the deal."

Teixeira's seat expires at the end of 2014, with an election for the seat occurring in June. That contest could go to a runoff in November, however, if one of the candidates doesn't get more than 50 percent of the votes.

Winn threw his hat in the ring, in part, because he believes he can help the county deal with issues such as water, which is at the forefront of supervisorial business with Paso Robles' rapidly depleting groundwater basin.

A currently split Board of Supervisors has recently looked at enacting emergency measures in Paso Robles designed to reduce water usage by vineyards and residents.

"If I am appointed, I can add my voice to those that are saying, 'Let's work this out," Winn said. "If I can help in this time of crisis, I feel I need to step up."

Winn sat on the NCSD and was a member of the county's Water Resources Advisory Committee for 12 years.

He also believes whoever is appointed to the job will need to be a good communicator and able to build some type of consensus on the board.

As someone with years of arbitration and mediation under her belt, Frederick feels she is a good fit for the position and applied for the job after numerous individuals from "different walks of life, political viewpoints and ethnicity" urged her to do so, she said.

"They all said I'd be a perfect person (for the job)," Frederick said. "I think I would do a good job. I know how to work well with people."

If selected for the seat, the longtime Nipomo resident feels it would be her job to look at issues from all viewpoints and listen to others' opinions before making a decision. She also wouldn't make her decisions based on political motivations or expediency and would plan to seek election in June, she said.

"I think I would bring the heart and dedication (to the office) that Paul brought," Frederick added.

Much like his counterparts, Harrison also believes he would do a good job as 4th District supervisor, and he, too, has applied for the job.

Having served on the NCSD for the past seven years and in public service for his entire adult life, Harrison knows his experience would serve him and the county well if he's selected to fill Teixeira's shoes, he said.

"You have to listen to everyone, and you deal with a lot of different people," he said, adding it would be his job as a county supervisor to make decisions and policies based on what's best for the community as a whole.

If tapped by the governor to replace Teixeira, Harrison would have to step down from his seat the NCSD board, leaving a vacancy on that elected body. His term expires at the end of 2014.

In Harrison's opinion, it's imperative that whoever is appointed to the Board of Supervisors is concerned about water supply and demand in the county, especially on the Nipomo Mesa.

Arroyo Grande residents Michael Byrd, Mark Millis and Caren Ray have also applied for the seat.

The 4th District represents Nipomo, Oceano, Arroyo Grande and a small portion of southern San Luis Obispo.

Dear Mr. Pedrotti,

The South County Advisory Council downloaded and reviewed the RDEIR for the Lactitia Agricultural Cluster Subdivision (Tract 2606) and, at the scheduled SCAC meeting on May 21, 2010, came to the following conclusions:

According to the testimony of neighbors of Laetitia, there is an already an apparently unmitigatable impact on the aquifer that has, even <u>prior</u> to the proposed subdivision, resulted in a drawdown in the surrounding areas, requiring deepening of existing wells or drilling of new wells on properties in neighborhoods adjoining Dana Foothill, Sheehey, and Rimrock Roads.

The RDEIR, itself, (p.v-51) reports, "With continued pumping, the water level in an aquifer near a well can continue to drop ("drawdown")until it reaches the bottom of the well screen or pump intake, or the water levels may stabilize if capture expands to equal the pumping rate....if the groundwater pumping exceeds the potential for capture, new equilibrium conditions are not possible (e.g., Bredehoft and Durbin, 2009; Walton, 2011; Alley and Leake, 2004)."

In addition, (p. v-54), The RDEIR reports, "Initial yield from wells in fractured bedrock aquifers is often not representative of longer term yields, which are typically lower. As groundwater is released from storage in fractures, the hydraulic gradient toward the well becomes progressively lower, which causes the well yield to decline (e.g., Robinson, Noble &Saltbush, 2004; Morrison-Maerle, 2002)"

Moreover, according to CEQUA Guidelines "Thresholds of Significance" (p. v-61), the RDEIR states, "For the purpose of the project specific evaluation in this EIR, significant water supply and infrastructure impacts would occur if the demands placed on this area from this development exceeded the available water supply,...or if the well capacity of adjoining parcels was diminished so as to create unsustainable yields or disruption of existing localized water supply...."

The consensus of council members is that the water issues on this tract are serious and cannot be mitigated.

In addition, neighbors of this development reminded us at this meeting of the equally serious traffic issues (not included in this RDEIR) inherent in this proposed development, and asked that you pay special attention to its impact on Dana Foothill, Rimrock, Sheehey, and Thompson Roads, which has worsened since 2004 with increased development and the increased traffic from Nipomo High School in the last eight years.

Traffic issues are of as much concern as water issues since the REIR states the "project is inconsistent with CalFire requirements for maximum road lengths which may result in significant fire hazard" ("Hazards and Hazardous Materials" DEIR, V1-4), and CalTrans and Public Works both recommended the Alternate Access Alternative (V1-41) as "...the existing at-grade intersection of Laetitia Vineyard Drive and Highway 101 operates at LOS F, and any additional trips would exacerbate this condition. In addition, CalTrans has

noted that this intersection's encroachment permit allows for winery and agricultural use, and is not approved for trips generated by residential land uses" ("#10 Alternative Access" DEIR, V1 41-42).

These traffic and fire safety issues indicate the need for a secondary (frontage) road for safe and proper access to this proposed development.

We therefore request you give close attention to the serious negative impacts of the proposed project in regard to water and traffic issues which affect the community and have not been mitigated.

On October 27, 2008, the SCAC reviewed the Laetitia Agricultural Tract Map and CUP Draft EIR. After hearing from Planner Brian Pedrotti, Allison Donatello, RRM and project representative, and over 20 potential "neighbors" of the proposed project, a motion was passed that the SCAC recommend against the acceptance of the Draft EIR for several important reasons, including down-played lack of water resources, severe and long range negative impact on traffic, circulation and safety, poorly mitigated negative environmental impacts, and significant noise, light air and odor pollution:

- 1 Water: As reported by Cleath and Associates, the hydrological engineers hired by the developers, (v-33-38), four new wells drilled from 2004-2005, when tested demonstrated a slow recovery. Since the current drought, neighboring wells, as reported by residents of Upper Los Berros, have dropped up to 40 feet. The well used by The Nipomo Ranch Mutual Water Company, which serves many residents in the area went dry, and the new well tapped after many tries yields
- sulfurous" water. This is an area of fractured shale, which has, historically failed to store water against drought (II-24, 31); the current residents of the area fear a loss of their homes to a further strain on the water supply; and an independent study of the applicant's claim that this project does not draw from the neighbors' aquifer is critical.
- Traffic and Circulation: As pointed out by the Chairman of the Traffic and 2 Circulation Subcommittee, the residual impacts must be considered and occupation of residential units, Dude Ranch facilities, equestrian facility, ranch headquarters, recreation center, community center, and, or, homeowner's association facility (III-6, III-11, III-49), should not be permitted until all CalTrans associated improvements are complete (v-210, TR/mm-5). In addition, Transit Impacts (v-212) will be significant. How will transit requests such as Dial-a-Ride, School Bus service, or fixed-route Service be accommodated? The neighbors to this proposed project cite the already dangerous winding, narrow rural roads,
- curves, and limited sight lines along the proposed ingress-egress route, none of Swhich they feel will be solved by a little widening and paving.

- 2. Environmental Impact: (BIO Impact 3 and BIO mm-14) The proposed removal of 300 Mature Live Oaks (II-4) can not be mitigated by the planting of the oak 22 seedlings which will take 50 years to mature to equal size and beauty. In addition the applicant in BIO/mm-16, on page Il-8, is allowed the option of mitigating 50% of the oak woodland impact through "funding to the California Wildlife Conservation Board to be used for the purchase of Oak Woodland Conservation Easements" in areas other than the one denuded. Even the Draft EIR finds this impact on the environment "adverse, significant and unavoidable." Add to this the negative impact on Los Berros Creek, its endangered species and habitat, and the possibility of groundwater contamination from effluent spills from the proposed wastewater treatment facility (//-30), air pollution from construction and increased traffic and noise.
- Air, Light, Noise, and Odor Pollution: The Draft EIR speaks to each of these 3. pollutants (II-15,16,), recognizing the reality of each and finding them "less than significant with mitigation." The neighbors would strongly disagree. Since the waste water treatment plant and effluent disposal areas are proposed to be built relatively close to Los Berros Creek and nearby existing residential areas, we would recommend relocation of the waste water treatment plant and effluent disposal areas elsewhere on the large Laetitia Vineyard & Winery property away from the flowing creek and existing residential areas (III-25, III-26, III-31 to III-29)
- At the SCAC meeting, you suggested an Alternative be selected from the Draft 4. EIR, but only two are fully outlined: No Project Alternative and Redesigned Project Single Cluster Alternative. The first, it is written, "failed to meet the project's objective to create places to live". What was suggested was "The environmentally superior alternative...the Redesigned Project Single Cluster Alternative" (II-78), "which would deter residents from using the Laetitia Vineyard Drive / Highway 101 at grade intersection during a non-emergency,"and, therefore send all traffic through upper Los Berros. What was missing was an expanded description of Alternatives 2: Reduced Project: Ordinance and General Plan Consistency, or for that matter, Alternatives 3, 5, 6, 7, and 8.

For all the above reasons, we recommend against the adoption of this Draft EIR and cannot choose an alternative without further description of all of them.

Court Rules Voter Initiative Cannot Force Water District to Set Rates Below Level Mandated by State Statute

Water Districts Must Be Able to Pay for Costs to Provide Water

AUGUST 13, 2013

In *Mission Springs Water District v. Verjil*, a California appellate court invalidated voter initiatives that had proposed to reduce a water district's recently adopted rate increases and limit the amount the district could raise future rates to the percentage increase, if any, in the Consumer Price Index. The court held that the local electorate does not have the power by initiative to set water rates so low that they are inadequate to pay the costs of the water district.

In a prior decision, *Bighorn Desert View Water Agency v. Verjil*, the California Supreme Court held that the California Constitution expressly authorizes the use of an initiative to reduce or repeal water rates. The court, however, also held that an initiative that seeks to "impose voterapproval requirements for future increases in fees and charges" was not authorized by the Constitution. The Supreme Court, however, declined to address whether the authorized initiative power is free of all limitations. In particular, the court did not determine "whether the electorate's initiative power is subject to the statutory provision requiring that water service charges be set at a level that 'will pay the open expenses of the agency, . . . provide for repairs and depreciation of works, pay the interest on bonded debt, and provide a sinking or other fund for the payment of the principal of such debt as it may become due."

The Mission Springs Water District (District) is a county water district established and operating pursuant to the County Water District Law. Under section 31007 of the California Water Code, the fees and charges collected by a county water district are required to be established so as to yield an amount sufficient to do each of the following:

- (a) Pay the operating expenses of the district.
- (b) Provide for repairs and depreciation of works owned or operated by the district.
- (c) Pay the interest on any bonded debt.
- (d) So far as possible, provide a fund for the payment of the principal of the bonded debt as it becomes due. It is intended by this section to require the district to pay the interest and principal of its bonded debt from the revenues of the district, except that this requirement is not intended to apply to a bonded debt for sewage disposal purposes.

The District presented extensive and detailed evidence at trial that the rate increases were absolutely necessary due to revenue declines and cost increases beyond the District's control. If the initiatives passed, the District would be unable to meet its costs, pay its debts and stay in business, and the potential consequences for the local water supply would be disastrous.

In its Aug. 8 decision, the appellate court recognized a 1995 Court of Appeal decision in *DeVita* v. County of Napa, which reasoned that "the local electorate's right to initiative . . . is generally

co-extensive with the legislative power of the local governing body," and that there is a "constitutionally based presumption that the local electorate could legislate by initiative on any subject on which the local governing body could also legislate." Thus, the court concluded in *Mission Springs Water District* that if the state Legislature has restricted the legislative power of a local governing body, that restriction applies equally to the local electorate's power of initiative and the voters may not exempt themselves by initiative from the requirements of Water Code section 31007. In sum, neither the District nor the electorate may set water rates so low that they are inadequate to pay the costs listed in Water Code section 31007.
