Program Requirements

- The clothes washing machine must be installed in address identified in the application prior to submitting the application.
- Only the homeowner of record of the single-family residence in the Nipomo Community Services District may participate in this program. Tenants are not eligible to participate.
- Retain a copy of this application for your records.
- Attach a copy of the sales receipt to this application. Receipt must include the make and model of the device purchased as well as the installation address. Receipt must be dated within the past 365 days of this application.
- The District will not honor rebates for used or reconditioned clothes washers.
- New construction is not eligible.
- All devices for which a rebate is issued are subject to an on-site installation verification inspection.

Rebate checks are generally mailed within 3 weeks after receipt of the completed application.
