The SB 1383 Challenge

- On January 1st of 2022, new regulations took effect that establish statewide greenhouse gas emissions reduction goals:
 - 75% reduction of organics disposed in landfills from the 2014 level.
 - 20% of edible food currently disposed must be recovered for human consumption.
- SB 1383 is the most aggressive waste reduction law to be adopted in California for the past 30 years.

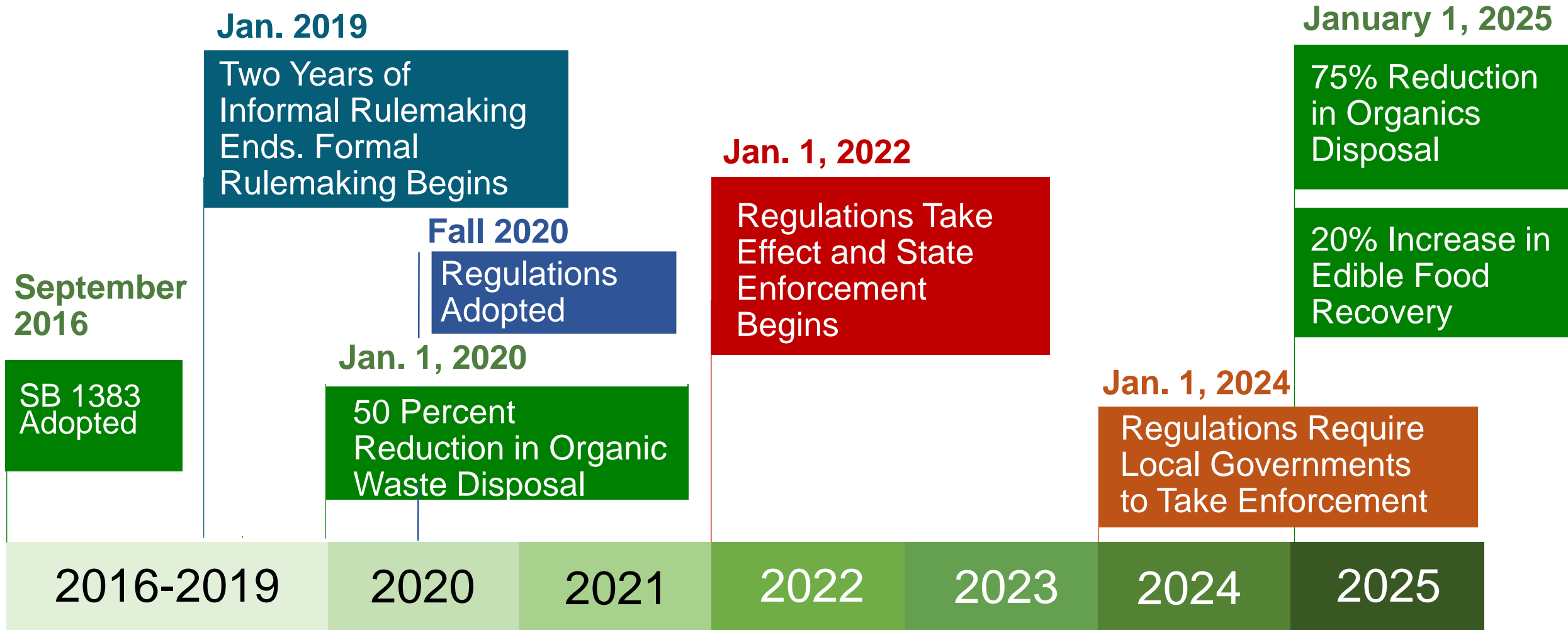

- Nipomo CSD is in Substantial Compliance with SB 1383.

WHAT ARE THESE FUNDS FOR?

These funds are to assist Local Jurisdictions in compliance with SB 1383.

NCSD Funding estimate \$75,000.00

Eligible projects include:

- Collection
- Edible Food Recovery
- Education and Outreach
- Enforcement and Inspection
- Program evaluation/Gap analysis
- Procurement Requirements
- Record Keeping

The IWMA is applying as a JPA for this grant and working with our 19 member jurisdictions to identify program gaps and areas of opportunity.

This is the 2nd round of funding from CalRecycle

The previous round of funding was offered in 2021.

Nipomo CSD authorized the IWMA to apply on their behalf to fund:

- ▶ Compost rebate program.
 - ▶ Meeting our Procurement Requirements
- ▶ Education and outreach.

Nipomo Community Services District Obligations?

- ▶ No matching funds
- ▶ No reporting requirements
- ▶ No additional staff time

The IWMA needs a letter of Authorization from the General Manager authorizing the IWMA to apply on your behalf.
