#### **BACKGROUND**

On May 15, 2024, the Office of the County Clerk-Recorder contacted the District and requested the District:

- 1. File a Notice of Offices to be Filled:
- 2. Provide a map of District Boundary; and
- 3. Provide a Resolution requesting consolidation with the November 5, 2024 General Election and a Resolution pertaining to the rules and costs for candidates' statements.

The draft Resolutions provide for the election of the District's Board of Directors to be consolidated on the ballot with the Statewide General Election conducted by the County on November 5, 2024, and adopting regulations for candidates and costs of candidates statements submitted to the voters.

The Notice and Map are due back to the County by June 28, 2024. The Resolution must be adopted and provided to the County Clerk Recorder no later than August 9, 2024.

Adopt attached Resolution approving consolidation of Board election with the General Election and direct staff to submit all election related material to the County Clerk Recorder no later than June 28, 2024.

- 1. That the cost of printing, handling, and mailing candidates' statements of qualifications shall be charged to the: CANDIDATE
- 2. That the candidates' statement of qualifications shall not exceed: "200" WORDS
- 3. The statement shall be filed with the County of San Luis Obispo Registrar of Voters at the time the candidate's nomination papers are filed.
- The statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00pm of the next working day after the close of the nomination paper.
- 5. That the candidates are not permitted to submit additional materials to be sent to the voter with the County Voter Information Guide.
- That the County of San Luis Obispo Registrar of Voters be directed to give a copy of these regulations to each candidate, or their representative, at the time that nomination documents are received.
